Welcome to our newest issue of the 42nd Combat Aviation Brigade newsletter.

My intent is to utilize this medium to communicate with all the Soldiers, their Families, significant others and employers. Ideally, the best form of communication is one-on-one or face to face, but is not always realistic with the busy schedules we all maintain.

This fiscal year has already been a very busy year as it was our first year after our Brigade transformation. We changed the way we did things by changing drill attendance. I have received a great deal of feedback and it appears the majority of personnel, due to time off issues with their employers or school, would prefer to return to the old drill schedule. I am looking at changing our drill program but do not intend to return to the MUTA 4 drill program. I believe the correct answer to allow us effective training and care of our soldiers, educators and employers is to work a drill schedule consisting of MUTA 5 and MUTA 6 drills and still have the month of December to be a non-drill month as well as a minimum of one month in the summer to allow unit members some quality Family time. I look forward to hearing feedback concerning this issue from all our Brigade Soldiers.

Currently we have one unit deployed, Detachment 1, Company B, 3rd Battalion, 126th GSAB (or CH47 unit) to Operation Enduring Freedom. They are performing in an outstanding manner and have received nothing but accolades from their higher units, the 82nd Cmbt Avn Bde and most recently the 101st Cmbt Avn Bde. It was brought to my attention that the 126th led the largest air assault conducted by the 82nd during their tour. The air mission

commanders and flight leaders were 1st Lt. (P) Eric Fritz and Chief Warrant Officer Francis Rotella. Chief Rotella is currently flying under the 101st Cmbt Avn Bde which is the same unit he flew with during his first tour in Viet Nam. This unit has done an amazing job and we look forward to their return very soon. I would be remise and would also like to thank the families of these Soldiers for the greater sacrifice they have endured while supporting their Soldier and allowing them to do their mission so successfully. Your sacrifice has not gone unnoticed for without you none of this would be possible.

The 126th will be returning and will be part of the new Family Readiness reintegration program designed to improve communications between returning Soldiers and their families. I truly hope all Families participate as this will be designed to take place away from the armory and is for the families. Further details will be published and distributed.

The Brigade is currently working diligently to prepare the 3rd Bn, 142nd Air Assault Battalion for their upcoming deployment in support of Operation Iraqi Freedom. The unit will be conducting a major training exercise next month to certify they are ready for movement to the mobilization station to complete their final preparations for deployment. The individuals in this unit were the first aviators to prepare for mobilization under the new deployment guidelines of the 12-month tour. This has required the personnel of this unit and those who have supported the training, to make additional time and sacrifice to meet the requirements to complete pre-mobilization training and reduce time at the mobilization station, thus providing ground commanders the maximum time in country. I would like to thank everyone involved in this endeavor and have every confidence that the second PPMT will be as successful as the first. The individuals in this unit, those supporting the training and their families and employers have made a great sacrifice to endure this train up to ensure our troops are prepared to deploy. There will be going away ceremonies for this Battalion on 31 May at Islip and on the 1 June in Latham. Details are forthcoming.

We are going through a time when maintaining and improving the number of Soldiers in

our ranks is our primary challenge. This can only be successful if every single Soldier within our ranks is involved. I ask that every Soldier do their utmost best to recruit good quality individuals and more importantly ensure we, as a command, are doing everything in our power to retain these Soldiers.

We as a command are working to obtain more school quotas, hire more full-time support, make training challenging, exciting and also fun. We can only do this with the input of every Soldier through their chain of command, being involved with the training plan and execution. We must also ensure we keep our Families informed as well as our employers to maintain their support for you, your unit and the New York National Guard.

Conducting a Soldier/NCO of the Year board



Step one: Command Sgt. Maj. Justin Cappon gets the board process started by getting the participating Soldiers in a relaxed frame of mind and explaining how the process will progress throughout the day, as well as the order in which each Soldier will appear before the board.



Step three: After completing the written test, each Soldier undergoes a scaled-down clothing and equipment inspection. Their individual items are inspected for condition of maintenance, if the item is still authorized and cleaniness





Step two: Each Soldier is given a timed written test on an array of military subjects. These subjects can range from drill and ceremony techniques to basic rifle marksmanship. Soldiers are prepared to take the test by either going on-line to read the study-guide or the printed version provided by their units.



Step four: Each Soldier reports to the board, addresses the board and is given a series of facing movements to execute. After that he/ she is instructed to be seated where they are asked various questions from each board member. These questions include basic military skills as well as topics about current social events. An individual session can last from 30-50 minutes.

Step five: Time to re-group. At the conclusion of the board, judges and participants hold a brief after-action review where the Soldier, NCO of the Year and runner-up are notified. Each participant is briefed on their performances and how they can improve the next time.
