This memorandum updates NGB-ARH policy memo #05-084, subject: Implementation of Authority to Reduce the Military Service Obligation (MSO) in Exchange for Selected Reserve Duty, 27 Jan 05 and now includes Individual Ready Reserve (IRR) Soldiers and revises the Officer, Warrant Officer, and Enlisted career

fields affected. The purpose of this message is to implement an incentive for IRR officers and enlisted Soldiers who have completed their initial active duty service obligation (ADSO) and still have a portion of their eight-year MSO remaining to serve in a designated skill in a SELRES unit.

3. Effective 1 January 2006, a four-year test was implemented offering a reduced MSO to Active Army Soldiers (officers and enlisted) departing active duty, who have completed their initial ADSO and still have a portion of their eight-year MSO remaining, to serve in a designated skill in a SELRES unit. Effective the date of this message, this test program is expanded to include Soldiers in the IRR, who transitioned from the Active Army and, who are otherwise eligible to join a SELRES unit. This four-year test program will expire NLT 31 December 2009. Eligible IRR Soldiers, who agree to serve in a designated skill in a SELRES unit of the Army National Guard (ARNG), will have an opportunity to reduce their MSO requirement by an amount corresponding to an equal amount of time in the SELRES. IRR Soldiers who transferred from a SELRES unit are not eligible for this incentive.

4. The following conditions apply:

a. Officers and enlisted Soldiers in the IRR are required to meet with an ARNG recruiting and retention NCO (79T). The reduction of MSO may be offered to eligible Soldiers to encourage SELRES service rather than completion of the remainder of their MSO in the IRR.

b. The remaining MSO may be reduced by one-half, equal to the length of the SELRES obligation, not to exceed two years (the statutory six years must be met). However, the Soldier must be able to serve a minimum of 12 months in a SELRES unit. Soldier's unit of assignment will ensure adjusted MSO date is entered in all required databases, personnel documentation, etc. during in-processing. If a Soldier is transferred back to the IRR for any reason prior to the completion of the selected reserve commitment, the MSO will be adjusted back to eight years.

c. An IRR officer or enlisted Soldier must have transitioned to the IRR following satisfactory completion of their initial ADSO to be eligible to participate in this program. Soldiers transferred to the IRR from a SELRES unit are not eligible for the MSO reduction program.

5. Specialties are based on the projected shortfalls in both reserve components. The new authority applies to officers in the specialties listed in Tab B and warrant officer specialties listed in Tab C. Officers must be MOSQ for the duty position (exception: officers assigned to 01A positions).

6. The new authority applies to specific enlisted MOSs listed in Tab D (Soldier must be MOSQ): (exception: (1) enlisted Soldiers SQI x qualified and assigned to a Drill Sergeant duty position, (2) not SQI x qualified and assigned to a Drill Sergeant duty position. Soldiers have 24 months to get SQI "x" qualified and keep the MSO reduction benefit.)

7. The following statement will go in the remarks block (continuation page) of the DA form 7249-r for the ARNG:

"I understand that the eight-year military service obligation (MSO), which I incurred on my original contract, has been reduced to reflect my agreement to serve in a selected reserve (SELRES) (M-day ARNG) unit for a period as indicated below. If I do not complete (for any reason) the SELRES contractual term for which I contracted, then my MSO will be adjusted back to the original eight-year statutory obligation date. If an alert order for mobilization results in "stop loss" of my assigned unit, I may be required to serve longer than my adjusted MSO date."

8. Affiliation bonus: Soldiers volunteering for this program may also be eligible for an affiliation bonus. Refer to current affiliation bonus implementation policy guidance for eligibility criteria and processing requirements.

a. Officers: To qualify for the officer affiliation bonus, an officer must serve for a minimum of three years, so it may be a rare instance where the individual is able to receive both the bonus and the reduced MSO.

b. Enlisted: Affiliation bonus amounts will not exceed the maximum amount authorized by the current ARNG and USAR SRIP policy in effect on the day the agreement is executed and signed. The SRIP rules are the same with or without the reduced MSO.

Affiliation bonus with MSO reduction example:

Soldier's ETS is 28 AUG 2006.

Non-adjusted MSO date is 14 May 2010.

Non-adjusted remaining MSO is 44 months.

Reduced MSO is 22 months without affiliation bonus.

Reduced MSO is 08 months with 3-year affiliation bonus (44 minus 36).

Reduced MSO is 00 months with 6-year affiliation bonus.
