Summary of Revision

DMNA Pamphlet Number 1-2, 12 January 2022 Administration – Incident Reporting

- This publication supersedes DMNA Pamphlet Number 1-2, 29 October 2010.
- Summary. This publication clarifies the serious incident report categories, and adds a category 4 for JFHQ-NY required reporting, and a category 5 for GOCOM required reporting. This publication changes the 11 Line Incident Report to a 12 Line Incident Report and adds Annex A Reports Matrix, to DMNA PAM 1-2.
- Applicability. This pamphlet applies to the Division of Military and Naval Affairs (DMNA) and its components. These components include service members, militia and civilian employees. This publication has no effect on units that are mobilized or deployed for federal active duty. The only exception is for support during pre-mobilization and accounting for non-deployable equipment.
- Distribution: This pamphlet has been revised from the 29 October 2010 edition and is available in electronic media only. This pamphlet is intended for all GOCOM's, company command and flight leadership levels for the New York Army National Guard, New York Air National Guard, New York Naval Militia, New York Guard and civilian employees.
- Supplementation: Supplementation is prohibited without prior approval from the Director of Administrative Support (MNAS). Establishment of command or local forms is authorized for actions internal to the command or office. These actions must not involve coordination outside of the command or office that has generated the form.

INTRODUCTION

1-1. PURPOSE. The purpose of DMNA Pam 1-2 is to disseminate established policies and procedures for reporting incidents. An incident occurs when the Division of Military and Naval Affairs (DMNA) personnel, equipment, and/or facilities are involved in occurrences listed in this pamphlet. The JOC acts as the command and control element for the Office of The Adjutant General (OTAG). It is imperative for the JOC to have visibility of all activities and actions in order to properly present a Current Operating Picture (COP) to the OTAG.

1-3. MISSION. The mission of the Joint Forces Headquarters-New York (JFHQ-NY) JOC is to provide continuous (24/7) situational awareness to the OTAG by monitoring, collecting and analyzing data in order to develop and update the COP pertaining to New York State Military Forces (NYMF) and their activities. The JOC will disseminate information to multiple internal directorates as well as government agencies as required to support missions and command decision making.

WHAT TO REPORT

2-1. WHEN IN DOUBT. Use the "*When in doubt, report*" rule. When there is the slightest question as to what is reportable, send notifications to higher headquarters within the limitations outlined in this pamphlet. These requirements exclude operations under Title 10 Federal Duty Status in a deployed location.

2-2. NOTIFICATION TIME/REPORTABLE ITEMS. The following items are to be reported to the Joint Operation Center (JOC) within 6 hours of incident during on-duty hours and 12 hours of incident during off-duty hours (Note: list is in alphabetic order).

2-3. AIRCRAFT. Class A, B or C Aircraft Mishap/Incident. Commands must not delay reporting pending an official determination of the mishap class. If there is a potential for a "Class C" or greater mishap, reporting procedures must be initiated. All commands will report. There is no case that a command will delay reporting regardless of pending notification of any intermediate headquarters.

2-4. AIRCRAFT EVACUATION. Aircraft evacuation for any reason not previously communicated to the JOC.

a. Execution of operational evacuation plans in accordance with (IAW) the CONPLAN will be considered previously communicated.

b. No report required for aircraft evacuated following a maintenance precautionary landing. This includes evacuation by means of a "One Time Flight" or by ground transportation.

c. Local aviation stand-down as required following post mishap or when command directed following any mishap regardless of injury to personnel or damage to the aircraft, aircraft system, (i.e. Unmanned Aircraft System/UAS) or property.

d. Local stand-downs required IAW regulation or as part of Safety Awareness/ Improvement Training do not require a report.

e. Any item regardless of size that falls off an assigned NYMF aircraft or UAS, regardless of assignment, to include operations under temporary assignment not in direct control of NYMF or area of operations, properties not managed by (i.e., out of state or federal property) or controlled by New York.

f. Any item regardless of size that falls off an aircraft or UAS, regardless of assignment (i.e., another state), operating from or utilizing New York airfields/properties/ training areas managed by or under the control of NYMF.

g. Damage to civilian property caused by NYMF assigned aircraft or UAS regardless of area operations. This includes aircraft or UAS not assigned (i.e., another state) operating under the control of NYMF.

h. Air National Guard units will report within Air Force regulations. Wing Command Posts will notify DMNA through the JOC when filing the written OPREP-3H.

i. Army National Guard units will report within Army regulations. Lower echelons will notify DMNA through the JOC via incident reporting procedures outlined in Chapter 3.

2-5. CBRNE. Any incident involving Chemical, Biological, Radiological, Nuclear or High-Energy (CBRNE) Weapon regardless of cause.

2-6. CLAIMS AGAINST DMNA. Any incident, accident, or injury involving DMNA personnel (civilian or military) while on duty, this could result in loss of time and or a claim against the government. Any incident, accident or injury to the civilian public, on DMNA property which may result in a claim against the government.

2-7. CLASSIFIED INFORMATION. Loss or compromise of classified information.

2-8. CONTACT WITH A CIVILIAN. Any action where a member of the New York Military Forces on duty in any status (IDT, SAD, AD, etc.) touches a civilian for any reason, to include, but not limited to, providing medical assistance.

2-9. CRIMINAL ACTIVITY. Attempted or actual criminal activity conducted against personnel, activities, facility, area or compound within the Command and Control of New York Military Forces to include Organized Militia facilities.

2-10. DEMONSTRATIONS OR PICKETING. Civil disturbances to include but not limited to picketing or demonstrations which have the potential impact or have impacted DMNA facilities.

2-11. DISASTER. Natural Disaster.

2-12. DISCHARGE OF A WEAPON. Discharge of a weapon, regardless of cause, outside of organized training environments.

2-13. Equal Opportunity. Racially or ethnically motivated discriminatory event or incident that results in death, injury requiring hospitalization, significant property damage or adversely affects the equal opportunity climate of a unit or installation.

2-14. EVENTS.

a. Any incident/accident involving civilians attending non-military events using any facility, area or compound within the Command and Control of NYMF to include facilities.

b. Event or incident of a military or political nature, foreign or domestic that involves members of the NYMF (regardless of duty status) or installations that may result in negative media attention.

2-15. FIRE OR EXPLOSION. Fire or explosion in any facility, area, or compound within the Command and Control of NYMF to include facilities.

2-16. FORCED ENTRY. Attempted or actual forced entry into any facility, area, or compound within the Command and Control of NYMF to include facilities.

2-17. ILLNESS OR INJURY.

a. Any illness or injury of Service Member (SM) on duty status requiring medical treatment or hospitalization.

b. The diagnosis of any disease or the extensive outbreak of any condition among NYMF personnel that may potentially degrade the operational readiness of a unit or installation.

c. The actual or presumptive diagnosis of any disease of potential epidemic significance that may require quarantine.

2-18. LOSS OF LIFE. Any loss of life of any member of the NYMF under any circumstance.

2-19. MEDIA. Event or incident of a military or political nature, foreign or domestic that involves members of the NYMF (regardless of duty status) or installations that may result in negative media attention.

2-20. OPREP-3. When an Operational Report (OPREP-3) is produced in accordance with Air Force Manual 10-206 by an Air Wing Command Post and is sent to the JOC, it will be considered reporting in accordance with this directive.

2-21. REQUEST TO EMPLOY NEW YORK MILITARY FORCES (NYMF).

a. Any request or action resulting in the employment of NYMF not operating under an active mission.

b. Joint Task Force Empire Shield (JTFES) will be considered operating under an active mission. This JTF will report through normal channels.

2-22. SURVEILLANCE. Any attempt or actual surveillance of NYMF personnel, activities, facilities, compounds, or areas within the Command and Control.

2-23. THEFT. Loss, theft, wrongful disposition, willful destruction, or mismanagement of evidence or sensitive items.

a. Theft of Federal or State property.

b. Actual or alleged incidents involving the theft, suspected theft, wrongful appropriation or willful destruction of Government property or appropriated funds of any value.

2-24. THREAT. Any man-made or natural threats against NYMF personnel, property and information systems.

- **a.** Bomb threats and suspicious packages/items.
- **b.** Sabotage and vandalism.
- c. Potential terrorist preoperational activities or other observed suspicious acts.
- **d.** Indicators of internal threats to include workplace violence.

HOW TO REPORT

3-1. TIMELY REPORTING. Timely reporting (within 6 hours) of the items noted in Chapter 2 is important in order to keep The Adjutant General, staff, and higher echelons apprised of events in effecting NYMF. If the event occurs after duty hours, the 6 hour reporting requirement is waived until 12 hours after the occurrence of the event. (See Appendix A and B).

3-2. METHOD OF REPORTING. The methods described below are not intended to supersede service specific reporting procedures.

- a. Methods of information dissemination will be (Note: this is in order of precedence):
 - I. Electronic mail (Non-Classified Internet Protocol Router Network) Microsoft Outlook Look-up: JOCOIC-NY or <u>ng.ny.nyarng.mbx.jocoic-emo@army.mil</u>.
 - II. Telephonically (Unclassified) (518) 786-6104/6105.
 - III. Facsimile (Unclassified) (518) 786-4922.
 - IV. Runner to physically hand carry the report to the JOC located at 330 Old Niskayuna Road, Latham, New York 12110.
- b. **12-Line Incident Report.** Reporting entities will use the 12-Line Incident Report format to report situations or incidents to the JOC. (See 5-2).
 - I. Line 1 Category. One of 5 categories, if an incident is covered in multiple categories, e.g. GOCOM category 5 and AR 190-45 category 1, use the lowest number, category 1:
 - a) Category 1 Serious incidents Per AR 190-45 PARA 8-2.
 - b) Category 2 Serious incident Per AR 190-45 PARA 8-3.
 - c) Category 3 Serious Incident Reports Per NGB G3 Memo PARA 5.
 - d) **Category 4** Serious incident Reports or DMNA-NY Internal SIR/IA based off of current TAG CCIR and DMNA PAM 1-2.
 - e) **Category 5** Serious Incident Reports are GOCOM internal SIR/IA based off current CG CCIR DMNA Pam 1-2.
 - f) Category 1-4 are reported to the JOC, Category 5 stays at GOCOM level.

- II. Line 2 Type of Incident. What happened, use titles from DMNA PAM 1-2 Annex A, Reports Matrix.
- III. Line 3 Date/time of incident. Enter the date time group of when the incident took place. DDTTTTMMMYYYY. e.g. 291300MAR2021 is 1300 on 29 March 2021.
- IV. Line 4 Location. Enter the City and State only.
- V. Line 5 Other Information.
 - a) Racial: Was this a racially motivated incident (yes or no)
 - b) **Trainee involvement**: Did this incident involved a trainee (yes or no)
 - c) **Source of Information**: How did the unit get the information, open source media, SM self-report, Chain of Command Report, etc.

VI. Line 6 Personnel Involved:

a) Service Member:

- 1. Name: Enter SM's FULL name.
- 2. Rank: Choose SMs rank from drop down menu.
- 3. **SSN:** Enter SMs Last 4 ONLY (XXX-XX-1234).
- 4. Race: Enter SMs Race.
- 5. **Sex:** Select Male or Female from drop down.
- 6. Age: Enter SM's Age at time of incident.
- 7. **Position:** Enter the SM's MOS/AFSC.
- 8. **Security clearance**: Select SM clearance level from the drop down.
- 9. Unit and Station of assignment: Enter the organic Unit, City and State.
- 10. **Next higher headquarters**: Enter the SM's next organic higher HQs,include city and state.
- 11. **Deployment History**: Only enter deployments within the last year. Location/ time frame.
- 12. **Duty Status**: Choose the appropriate duty status at the time of the incident.
- b) **Non DMNA Employee Suspect/Victim**: Enter the non DMNA Employee information and relationship to the SM if applicable. If none, N/A.
- VII. **Summary of incident**: Enter a brief narrative summary of the incident. Tell the WHO, WHAT, WHERE, WHEN, WHY AND HOW. Be clear and concise.
 - a) Injuries: Enter any injuries sustained if none enter N/A.
 - b) **Property or vehicle damage:** Enter any property or vehicle damage to include if it was Tactical, GSA, Rental or State.
- VIII. **Remarks:** Enter action taken and any additional remarks: e.g. "Police report to follow".
- IX. **Publicity:** Chose an item from the drop down.

- X. **NOK notified:** Chose an item from the drop down.
- XI. Commander Reporting: Name and rank of Unit Commander making the report.
- XII. **Point of contact:** Unit POC with phone number and email.
 - a) **Prepared by**: Name, Rank, phone number of who prepared form.
 - b) DTG Reporting: DTG when SIR was sent.
 - c) **Reviewed by**: Name, Rank, phone number of the last SM to review the SIR (BN POC, BDE POC, GOCOM POC) only the last reviewer is needed.

REPORTING CHANNELS

4-1. INITIAL REPORTING. Incident reporting should always go through the proper chain-of-command and then reported to the JOC.

4-2. CONTINGENCY REPORTING.

a. In the event communications are not available to the JOC, JTFES may be utilized as an intermediate dissemination point (718) 765-7260.

b. In the event JTFES is utilized as the intermediate dissemination point, reporter will continue to attempt to telephonically notify the JOC in order to notify the controller of the action to ensure that follow-up is conducted with JTFES in order to gather the reports.

4-3. NEW YORK AIR NATIONAL GUARD (NYANG) REPORTING.

a. NYANG units will report all incidents in accordance with Air Force Manual 10-206 as applicable.

b. If the item, event, or action is not addressed in Air Force Manual 10-206, Attachment 2, send the 12-Line report to the JOC in accordance with this publication.

c. The Wing Command Post will be considered the primary point of contact for reports from the Wing level to the JOC.

d. In the event the Command Post is closed, the alternate point of contact for reports will be the Wing's Base Defense Operation Center (BDOC).

e. If the event occurs after Command Post duty hours, the 6 hour reporting requirement is waived until 6 hours after the next opening of the command post. This rule applies, unless Air Force Manual 10-206 is invoked for the reporting in which case the 6 hour limitation remains in effect.

4-4. NEW YORK ARMY NATIONAL GUARD (NYARNG) REPORTING.

- **a.** NYARNG units will report all incidents through their chain-of-command channels.
- **b.** GOCOMs will be responsible for reporting to the JOC.

4-5. NEW YORK NAVAL MILITIA (NYNM) REPORTING.

a. NYNM units will report all incidents immediately to the JOC, with a copy to Headquarters, NYNM by electronic mail or telephonically.

4-6. NEW YORK GUARD (NYG) REPORTING.

a. NYG units will report all incidents immediately to Headquarters, NYG by electronic mail or telephonically.

b. Upon receipt of notification of an incident, Headquarters, NYG will notify the JOC for processing of item, event, or action.

4-7. CAMP SMITH TRAINING SITE (CSTS) REPORTING.

- a. CSTS will report through MNFE.
- **b.** MNFE will report to the JOC any item, event, or action utilizing electronic mail.

4-8. SURFACE MAINTENANCE SHOPS REPORTING.

- **a.** Surface Maintenance Shops (CSMSs, UTESs, and OMSs) will report to the Logistics Directorate (MNL).
- **b.** MNL will send the report to the JOC within 6 hours of receipt for processing.

4-9. UNITED STATES PROPERTY AND FISCAL OFFICE-NY (USP&FO) REPORTING.

- **a.** All elements under the USP&FO will submit reports to the USP&FO.
- **b.** USP&FO will send reports to the JOC within 6 hours of receipt for processing.

4-10. ARMY AVIATION SUPPORT FACILITIES (AASF) REPORTING.

- a. AASF will send reports to the Director of Aviation and Safety (MNAV-OS).
- **b.** MNAV-OS will send the report to the JOC within 6 hours of receipt for processing.

4-11. FACILITIES OFFICERS IN CHARGE AND CONTROL (OIC&C) REPORTING.

- **a.** Facilities OIC&C of state armories will send reports to Directorate of Facilities Management and Engineering (MNFE).
- **b.** MNFE will send the report to the JOC within 6 hours of receipt for processing.

FOLLOW-UP

- **5-1. DIRECTORATE RESPONSIBILITIES.** DMNA directorates will follow-up on incident reports provided to them by the Office of The Adjutant General or the Joint Operations Center to conduct any follow-on actions as required. Examples of Directorate level actions include (but are not limited to) accident reporting, line of duty investigation, legal claims, safety issues, or facility issues, etc.
- **5-2. NYNG UNIT RESPONSIBILITIES.** All NYNG units will provide any applicable updates to previously submitted SIRs to the JOC as required for further processing and action.




APPENDIX A
