ABBOTT, JAMES H. — Age, 19 years. Enlisted at Plattsburgh, to serve one year, and mustered in as private, Co. H , August 25, 1864; captured in action, October 30, 1864, near Petersburg, Va. ; **no further record**; also borne as James Abott and Abbatt. [ Mother and brother apply for pension in October 1879 ]

ACKERMANN, SAMUEL. — Age, 34 years. Enlisted, August 27, 1864, at Poughkeepsie, to serve three years; mustered in as private, Co. E , September 3, 1864; **wounded on picket and died of his wounds, October 28, 1864, at City Point Hospital, Va. ;** also borne as Ackerman. [ Gunshot wound of left lung. Left a child in guardianship in Switzerland. His wife had divorced him in March 1863. See 53 pages of minor's pension file at [www.fold3.com](http://www.fold3.com) ]

ACORN, JR., JOHN. — Age, 18 years. Enlisted, August 23, 1864, at Plattsburgh, to serve one year; mustered in as private, Co. H , September 3, 1864; captured in action, October 30, 1864, near Petersburg, Va. ; **died, November 10, 1864, at Salisbury, N. C.**; also borne as Acorne and Acorn. [ NO PENSION APPLICATION FOUND/ NPAF **|| IN Louis Brown list as Acome, John, Pvt., H, 69th NY, 11-11-64** ]

ARCHABALD, WILLIAM J. —Age, 19 years. Enlisted at Avon, to serve one year, and mustered in as private, Co. E, August 31, 1864; captured on picket, October 30, 1864, near Petersburg, Va.; paroled, no date; mustered out on individual roll, July 13, 1865, at Elmira, N. Y , as William S. Archibald; also borne as William Y. and William A. Archibald. [ NPAF ]

ADAMSON, AUGUSTUS.— Age, 39 years. Enlisted at Tomkinsville, to serve one year, and mustered in as private. Co. I, September 8, 1864; captured on picket, October 30, 1864, at; Petersburg, Va.; confined at Richmond, Va., October 31, 1864; *sent to Salisbury, N.C., November 4, 1864; no further record. [ NPAF ]*

ARNOLD, MARTIN.— Age, 18 years. Enlisted, August 25, 1861, at Plattsburgh, to serve one year; mustered in as private, Co. H, September 3, 1864; captured in action, October 30, 1864; paroled, February 28, 1865; mustered out on individual roll, July 6, 1865, at Annapolis, Md. [ Died April 26, 1910 ]

BAMFORD, SAMUEL.— Age, 21 years. Enlisted at Brooklyn, to serve three years, and mustered in as private, Co. C, January 20, 1864; captured in action, October 30, 1864, at Petersburg, Va.; released, May 17, 1865; absent, sick, at muster-out of company; also borne as Banford, Barford and Bauford. [ NPAF ]

BARST, JACOB.— Age, 20 years. Enlisted at Jamaica, to serve one year, and mustered in as private, Co. C, October 10, 1864; captured, October 30, 1864, at Petersburg, Va.; paroled, no date; absent, sick, at muster-out of company; also borne as Isaac and as Boast, Boss and Bost. [ NPAF ]

BARTON, LEWIS.— Age, 18 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. G, January 21, 1864; captured in action, October 30, 1864, near Petersburg, Va.; released, no date; mustered out with company, June 30, 1865, near Alexandria, Va. ; also borne as Baston. [ NPAF ]

BAUER, ANDREW— Age, 22 years. Enlisted, September 1, 1864, at Brooklyn, to serve three years; mustered in as private, Co. H , September 3, 1864; captured in action, October 30, 1864, near Petersburg, Va. ; *sent to Salisbury, NC., November 4, 1864, and absent at muster-out of company.* [ NPAF ]

BIGALOW, JONATHAN. — Age, 24 years. Enlisted at New York city, to serve one year, and mustered in as private, Co. C, September 23, 1864; captured, October 20, 1864, at Petersburg, Va.; paroled, February 28, 1865; mustered out on individual roll, June 1, 1865, at Camp Parole, Annapolis, Md.; also borne as Biglor.[ Died March 15, 1922 at Newfoundland, NJ ]

BLENIN, JOHN.—Age, date, and place of enlistment not stated; mustered in as private, ,Co. H , September 3, 1864; captured, October 30, 1864, near Petersburg, Va. ; **died on or about February 28, 1865, at Florence, S. C** ; also borne as Belmen and Blenen. [ Johan Blaha at [www.fold3.com](http://www.fold3.com) Captain Maurice Wall writes, in 1888, that the soldier died at Salisbury---which makes more sense. Also started in 1869, this claim seems to have taken quite a while to settle for the orphaned son. ]

BOWER, HENRY. — Age, 18 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. G, January 22, 1864; captured, October 30, 1864, near Petersburg, Va.; returned to duty, May 17, 1865; mustered out with detachment, June 13, 1865, near Alexandria, Va. ; also borne as Borrer and **Bowers**. [ Lived to at least 1911 ]

BOWERS, GEORGE. — Enlisted, August 29, 1864, at Schenectady, to serve one year; mustered in as private, Co. H , September 1, 1864; **missing in action, October 30, 1864**; no record subsequent to April 30, 1865, as dropped. [ NPAF ]

BRADDOCK, THOMAS. — Age, 19 years. Enlisted at Brooklyn, to serve one year, and mustered in as private, Co. K , October 10, 1864; captured, October 30, 1864, near Petersburg, Va. ; paroled, February 28, 1865; furloughed from Camp Parole, Annapolis, Md., March 10, 1865, to New York city, and absent at muster-out of company; also borne as George Bradcock.[ NPAF ]

BRADY, CHARLES.— Age, 30 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. K, May 23, 1864; captured in action, October 30, 1864, near Petersburg, Va.; died of disease, December 21, 1864, at Salisbury, N. C , in prison. [ NPAF ] [ IN Brown as Bradey, Chas., Pvt., K, 69th NY, 12-22-64 ]

BREARTON, JOHN. — Age, 29 years. Enlisted at Tompkinsville, to serve one year, and mustered in as private, Co, E, September 29, 1864; captured on picket, October 30, 1864, near Petersburg, Va. ; absent at Annapolis, Md. , at muster-out of company; also borne as Brereton. [ NPAF ]

BRENNEN, WILLIAM. — Age, 21 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. G, August 18, 1864; captured, October 30, 1864, near Petersburg, Va. ; prisoner until April 29, 1865; mustered out on individual roll, June 29, 1865, at New York city; also borne as Brannon, Brennan, and Brennon.

BRENNON, WILLIAM. — Age, 21 years. Enlisted at New York city, to serve one year, and mustered in as private, Co. G, August 18, 1864; captured, October 30, 1864, before Petersburg, Va. ; mustered out on individual roll, to date June 30, 1865, at New York city; supposed to be identical with William Brennen. [ Applies as an invalid in July 1869---not granted ]

BURKE, PATRICK. — Age, 23 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. E, December 9, 1863; captured on picket, October 29, 1864, near Petersburg, Va. ; paroled, March 14, 1865, at Wilmington, N. C ; mustered out on individual roll, June 8, 1865, at Annapolis, Md. ; also borne as Bourke and Burk. [ NPAF ]

BURNS, DENNIS—Age, 22 years. Enlisted, September 2, 1864, at Schenectady, to serve one year; mustered in as private, Co. I, September 23, 1864; captured on picket, October 30, 1864, at Petersburg, Va. ; recaptured at Salisbury, N.C. , no date; mustered out on individual roll, August 14, 1865, at New York city. [ NPAF ]

BUSHAY, THOMAS.—Age, 20 years., Enlisted, January 19 1864, at Brooklyn, to serve three years; mustered in as private Co. C, January 28, 1864; captured, October 30, 1864, before Petersburg, Va. ; gained to company, May 17, 1865; mustered out on individual roll, July 1, 1865, at New York city, as Busby. [ NPAF ]

CALLAHAN, JAMES. — Age, 30 years. Enlisted, August 31, 1864, at Brooklyn, to serve three years; mustered in as private, Co. H , September 3, 1864; **missing in action, October 30, 1864**, near Petersburg, Va. , and at muster-out of company. [ NPAF ]

CAMP, ADAM.— Age, 28 years. Enlisted at Kingston, to serve one year, and mustered in as private, Co. C, October 10, 1864; captured in action, October 29, 1864, at Petersburg, Va. ; released, May 13, 1865; mustered out June 24, 1865, at New York city. [ Died June 29, 1895 at Milwaukee, WI ]

CLAMPETT, PATRICK. — Age, 19 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. K, March 29, 1864; captured, October 30, 1864; paroled, no date; discharged, March 31, 1865, to enlist as hospital steward in United States Army; also borne as Patrick J . Clampitt. [ Died October 4, 1874 ]

CLEARY, DENIS.— Age, 24 years. Enlisted, September ,11, 1861, at New York city, to serve three years; mustered in as private, Co. G, September 12, 1861; transferred to Co. A, June 12, 1863; re-enlisted as a veteran, December 22, 1863; transferred to Co. E, in January or February,1864; captured on picket, October 30, 1864, before Petersburg, Va. ; paroled, no date; mustered out with company, June 30, 1865, at Alexandria, in Va. ; also borne as Clarey and Clearry. [ NPAF ]

CLEARY, JOHN. — Age, 20 years. Enlisted at Jamaica, to serve one year, and. mustered in as private, Co. F , September 27, 1864; captured on picket, October 30, 1864,before Petersburg, Va.; absent, at Annapolis, Md., at muster-out of company; also borne as Clary. [ NPAF ]

COLE, FRANKLIN. — Age, 18 years. Enlisted, August 23, 1864, at Plattsburgh, to serve one year; mustered in as private, Co. H, September 3, 1864; captured in action, October 30, 1864, at Petersburg, Va. ; **died, November 27, 1864, at Salisbury, N.C.**, as Franklin B. Cole; .also borne as E. George Cole, George F. Cole and George P . Vole. [ Mother and father apply in April 1871 ]**[ ???IN Brown as Coll, John, Pvt., H, 69th NY, 2-1-65 ]**

COLLINS, WILLIAM A . — Age, 22 years. .Enlisted, January 17, 1864, at Williamsburgh, to serve three years; mustered in as private, Co. C, January 18, 1864; promoted corporal, no date; captured in action, October 30, 1864, at Petersburg, Va. ; paroled and returned to ranks, no dates; mustered out on individual roll, June 29, 1865, at *Camp Chase, Ohio*; also borne as William Collins.[ Died January 15, 1920 at National Military Home, KS ] [ Camp Chase was a Union prisoner of war camp. ]

CONNELLY, JOHN. — Age, 32 years. Enlisted at Jamaica, to serve one year, and mustered in as private, Co.C., September 28,. 1864; captured in the trenches, October 30, 1864, at Petersburg-, Va.; paroled, no date; mustered out with detachment, May 28, 1865, at. Ladies' Home Hospital, New York city; also borne as Connoly, Conely and Conley. [ NPAF ]

COSTELLO, THOMAS. — Age, 27 years. Enlisted at New York city, to serve one year, and mustered in as private, Co. I, September 7, 1864; captured on picket, October 30, 1864, at Petersburg, Va. ; paroled and returned to duty, April 20, 1865; mustered out with detachment, June 5, 1865, near Alexandria, Va. [ NPAF ]

COX, HENRY. — Age, 19 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. F, September 27, 1864; captured, on picket, October 30, 1864, before Petersburg, Va. ; discharged, to date June 30, 1865. [ NPAF ]

CRANDELL, ALEXANDER.—Age, 18 years. Enlisted, August 30, 1864, at Troy, to serve one year; mustered in as private, Co. H, September 3, 1864; captured in action, October 30, 1864, near Petersburg, Va.; released, March 13, 1865, at Aikens Landing, Va.; mustered out on individual roll, June 21, 1865, at Annapolis, Md., as Alexander H. Crandall [ Lived to at least 1911 ]

CRANNEY, JOHN.— Age, 37 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. A, November 11, 1862; wounded in action, July 2, 1863, at Gettysburg, Pa.; transferred to Co. F, in January or February, 1864; captured on picket, October 30, 1864, before Petersburg, Va.; rejoined company, May 19, 1865; mustered out with detachment, June 5, 1865, near Alexandria, Va.; also borne as Cranny and Creaney. [ Died January 4, 1867 of phthisis pulmonalis related to captivity at Salisbury. First seen by physician in September 1865. His deposition is on pages 7-9 at widow's pension file on [www.fold3.com](http://www.fold3.com) ]

CROSS, FRANCIS. — Age, 27 years. Enlisted, August 30, 1864, at Troy, to serve one year; mustered in as private, Co. H, September 3, 1864; captured in action, October 30, 1864, near Petersburg, Va. ; released, May 1, 1865; mustered out on individual roll, July 24, 1865, at New York city. [ Lived to at least 1891 ]

CURTISS, THOMAS.— Age, 28 years. Enlisted at Camden, to serve three years, and mustered in as private, Co. K, December 15, 1863; captured, October 30, 1864; paroled, no date; mustered out with company, June 30, 1865, at Alexandria, Va. ; also borne as James Curtis. [ Died January 20, 1915 at Washington, DC.

DALTON, ANDREW. — Age, 37 years. Enlisted, January 26, 1864, at Brooklyn, to serve three years; mustered in as private, Co. C, January 28, 1864; absent, sick, since August, 1864, and at muster-out of company; also borne as Dalten. [ “ Martin O’ Gorman and Patrick Hegan (or Kegan) swear soldier was taken prisoner October 30, 1864 & died a prisoner of war at Andersonville on or about December 17, 1864.” Martin gives his statement on page 15 at [www.fold3.com](http://www.fold3.com) and Patrick on page 26. Neither statement is very convincing to me, or the investigators in the file. Nonetheless, widow Mary and child Jane get a pension in February 1870.]

GORMAN, MARTIN.— Age, 20 years. Enlisted, January 21, 1864, at Brooklyn, to serve three years; mustered in as private, Co. C, January 28, 1864; wounded in action, May 5, 1864, at the Wilderness, Va.; deserted, July 20, 1864, from Finley Hospital, at Washington, D. C.

HEENAN, PATRICK.— Age, 21 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. B, October 2, 1861; deserted, same date, at New York city.

DARLING, WILLIAM. — Age, 18 years. Enlisted, August 21, 1864, at Plattsburgh, to serve two years; mustered in as private, Co. H, September 3, 1864; captured in action, October 30, 1864, near Petersburg, Va. ; died, November 25, 1864, at Salisbury, N. C.; also borne as William H. [ Widow applies in April 1896 ] [ IN Brown as Darling, Wm., Pvt., K, 69th NY, 11-25-64 ]

DECKER, ANDREW. — Age, 25 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. C, July 20, 1864; captured in action, October 30, 1864, before Petersburg, Va. ; discharged for disability, May 27, 1865, at Baltimore, Md.[ NPAF ]

DELAINEY, WILLIAM. — Age, 21 years. Enlisted, October 6, 1861, at New York city, to serve three years; mustered in as private, Co. I, October 30, 1864; wounded in action, December 13, 1862, at Fredericksburg, Va.; transferred to Co. A , June 12, 1863; re-enlisted as a veteran, December 21, 1863; transferred to Co. E in January or February, 1864; captured on picket, October 29, 1864, at Petersburg, Va. ; gained, May 19, 1865; promoted sergeant, June 7, 1865; mustered out with company, June 30, 1865, at Alexandria, Va. ; also borne as Delaney and Delany.[ NPAF ]

DEMAREST, ISRAEL. — Age, 28 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. G, August 17, 1864; **absent, missing in action, since October 30, 1864, and at muster-out of company**; also borne as Demerest and Demorest.[ NPAF ]

DEMAREST, PETER L. — Age, 31 years. Enlisted at Tarrytown, to serve one year, and mustered in as private, Co. D, August 30, 1864; promoted corporal, October 1, 1864; **killed on picket, October 26, 1864, before Petersburg, Va.** ; also borne as Peter G. and as Peter S. Demerest. [ See [www.fold3.com](http://www.fold3.com) Shot in the head. 113 pages of widow's pension file. ]

DENICK, JOHN — Age, 24 years. Enlisted, August 31, 1864, at New York city, to serve three years; mustered in as private, Co. H , September 3, 1864; captured in action, October 30, 1864, at Petersburg, Va. ; paroled, February 28, 1865, at North East Ferry, N.C. ; furloughed, March 13, 1865, from Camp Parole, Md. ; **no further record**; also borne as Derrick.[ NPAF ]

DENNY, PATRICK. — Age, 21 years. Enlisted at New York city, to serve one year, and mustered in as private, Co. K, October 13, 1864; **absent, prisoner of war, since October 30, 1864, and at muster-out of company**; also borne as Dennee and Denney.[ NPAF ]

DEVIN, ALEXANDER.—Age, 27 years. Enlisted at Poughkeepsie, to serve one year, and mustered in as private, Co. G, August 17, 1864; captured in action, October 30, 1864, near Petersburg, Va. ; returned to duty, May 15, 1865; mustered out with detachment, June 5, 1865, near Alexandria, Va. ; also borne as Devans, Devens and Devins. [ NPAF ]

DIEDLY, JOHAN A . — Age, 20 years. Enlisted, August 29, 1864, at Tarrytown, to serve three years; mustered in as private, Co. H , September 3, 1864; **missing in action, October 30, 1864, near Petersburg, Va., and at muster-out of company**; also borne as John Deadly, Deedly and Diettle. [ NPAF ]

DIGAN, BERNARD. — Age, 38 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. G, August 19, 1864; captured, October 30, 1864, near Petersburg, Va. ; returned to duty, May 25, 1865; mustered out with detachment, June 13, 1865, near Alexandria, Va. ; also borne as Deegan and Degan. [ NPAF ]

DONOVAN, DENNIS.— Age, 30 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. K, August 19, 1862; wounded in action, September 17, 1862, at Antietam, Md.; transferred to Co. A, no date; promoted corporal and returned to ranks, no date; transferred to Co. F in January or February, 1864; captured on picket, October 29, 1864, near Petersburg, Va.; regained, May 19, 1865; mustered out with detachment, June 5, 1865, near Alexandria, Va.; also borne as Donnovan. [ Appears to have died around June 1890 ]

DOYLE, DENNIS. — Age, 19 years. Enlisted, October 20, 1861, at Syracuse, to serve three years; mustered in as private, Co.K. , November 17, 1861; transferred to Co. A, June 12, 1863; promoted corporal, no date; killed in action, July 2, 1863, at Gettysburg, Pa. ; also borne as Doyal and David Doyle.[ ?????IN Brown as Doyle, Dennis, Pvt., A, 69th NY, 12-12-64 ]

DOWDALL, CHARLES. — Age, 26 years. Enlisted at Niagara, to serve one year, and mustered in as private, Co. E, September 19, 1864; absent, **missing in action, near Petersburg, Va. , since October 29, 1864, and at muster-out of company**; also borne as Dowdell.[ NPAF ]

DUAL, EVANGELIST. — Age, 18 years. Enlisted, August 23, 1864, at Plattsburgh, to serve three years; mustered in as private, Co. H , September 3, 1864; captured in action, October 30, 1864, at Petersburg, Va.; mustered out with detachment, June 20, 1865, at United States General Hospital, Summit Home, Philadelphia, Pa. ; also borne as Evangelie Duval. [ NPAF ]

ECK, MICHAEL J. — Age, 25 years. Enlisted, August 27, 1864, at Troy, to serve one year; mustered in as private, Co. H , September 3, 1864; captured in action, October 30, 1864, at Petersburg, Va. ; paroled, no date; mustered out on individual roll, May 27, 1865, at hospital, Albany, N.Y. [ Lived to at least 1897? ]

FARMER, ROBERT— Age, 22 years. Enlisted, January 18, 1864, at Brooklyn, to serve three years; mustered in as private, Co. C, January 28, 1864; promoted corporal, October 10, 1864; captured in action, October 30, 1864, before Petersburg, Va. ; **died, December 25, 1864, at Salisbury, NC**. ; also borne as Tarneer.[ Mother applies in February 1869 ][ NOT found in Brown ]

FOGG, JACOB.— Age, 23 years. Enlisted, August 30, 1864, at Troy, to serve one year; mustered in as private, Co. H, September 3, 1864; captured in action, October 30, 1864, near Petersburg, Va.; paroled, March 2, 1865, at Northeast Ferry, N. C., and furloughed from Camp Parole, Md., March 19,

1865, for thirty days, to Albany, N. Y.; absent at muster out of company. [ NPAF ]

FREEMAN, JOHN.—Age, 18 years. Enlisted, August, 25, 1864, at Plattsburgh, to serve one year; mustered in as private, Co. H, September 3, 1864; captured in action, October 30, 1864, near Petersburg, Va.; paroled, March 10, 1865; discharged, May 1, 1865; also borne as George Freeman. [ Died in 1906 ]

FUSIA, FREDERICK. — Age, 27 years. Enlisted, August 21, 1864, at Plattsburgh, to serve one year; mustered in as private, Co. H, September 3, 1864; captured in action, October 30, 1864, near Petersburg, Va. ; confined at Richmond, Va., October 31, 1861; sent to Salisbury, N C., *November 4, 1864*, *and absent at muster-out of company*; also borne as Forsia and Forsid. [ NPAF ]

GANNON, THOMAS.— Age, 38 years. Enlisted at New York city, to serve one year, and mustered in as private, Co. C, October 13, 1864; captured in action, October 30, 1864, near Petersburg, Va.; **died, December 13, 1864, at Salisbury, N. C.**; also borne as Thomas H.[ See 17 pages of widow's pension file at [www.fold3.com](http://www.fold3.com) ][ IN Brown as Gannon, Thomas, Pvt., A, 69th NY, 12-13-64 ]

GARDAPHI, HOLINS.— Enlisted,. August 25, 1864, at Plattsburgh, to serve one year; mustered in as private, Co. H, September 3, 1864; captured, October 31, 1864, near Petersburg, Va.; paroled, March 10, 1865; mustered out, to date May 14, 1865; also borne as Holmes Gardelphe, Gardolphei, Gardolphi and Gardophy.[ Applied as an invalid in 1882; no death date given ]

GARRETT, SIDNEY.— Age, 19 years. Enlisted at Malone, to serve three years, and mustered in as private, Co. D, August 24, 1864; wounded in action, September 16, 1864; captured in action, October 30, 1864, near Petersburg, Va.; paroled, no date; mustered out with detachment, June 20, 1865, at Summit House United States General Hospital, Philadelphia, Pa., as Garret.[ Died in 1910 ]

GEARY, JOHN H . — Age, 18 years. Enlisted at Tompkinsville, to serve one year, and mustered in as private, Co. E, September 28, 1864; captured on picket, October 29, 1864, before Petersburg, Va.; paroled at North East Ferry, N. C , February 28, 1865; no further record.[ **Died as a POW in October 1864**. GREEVER, ANTHONY. — Age, 25 years. Enlisted, February 2, 1864, at Brooklyn,, to serve three years; mustered in as private, Co. E, March 19, 1864; transferred to Co. K , no date; promoted corporal, no date; captured, October 30, 1864; mustered out on individual roll, July 15, 1865, at New York city; also borne as Antone Greevan, Antoine Greiver and Griever. GROPPE, FRANCIS. — Age, 34 years. Enlisted at Tompkinsville, to serve one year, and mustered in as private, Co. I , September 17, 1864; captured on picket, October 30, 1864, at

Petersburg, Va., arrived at Annapolis, Md., and admitted to division hospital No 1, March 10, 1865; furloughed, March 16, 1865; absent at muster-out of company.[ NPAF ]

About 128 captured men here from October 30. Along with 83-90 of the 111<sup>th</sup> New York captured on the same night of October 30, 1864, the Confederates mounted a brilliant action that got them over 200 Yankees with barely a shot fired, although 14 of this group are mentioned as missing in action. How did the Rebels do it? The bayonet must have played its silent role here if the missing were actually killed. On the night before, 12 men were captured and 4 went missing or “no further record.”

Two men deserted on October 26. Both were from Company I; both older men; both were recruits with six weeks or less time in the service. Malloy was Irish surnamed and enlisted from Jamaica, NYC. Was he who he claimed to be?

General Clinton D. MacDougall thought that deserters to the enemy may have been responsible for the captures, in particular those from the 69<sup>th</sup> New York. However, in William Canton, who deserted to the enemy on October 15 after about six weeks of service, he would have one of his own to suspect, if that were the case.

My own theory is that some Irish Confederate ex-prisoners had taken advantage of the Oath of Allegiance while at a Yankee prison and made their ways to New York City where they could enlist in a Yankee regiment with less scrutiny towards false names and identities than a man from small town rural New York might receive. What would just another O'Brien or Riley or Malloy from the Irish immigrants of NYC be to a summer of 1864 recruiting officer? Once on the front, they could return to their units by deserting the Yankees. Perhaps with a service done to the Confederacy while they were at it? That is, a man could not help but notice that his Yankee comrades were mostly green as grass and easy pickings. Only 36 of this group were veterans; 90 were August, September, and October raw recruits.

Obviously, there can be no hard proof here of Confederate intrigue. However, there's another circumstance here amongst the men of the 69<sup>th</sup> NY. In the case of Company I, 4 or maybe 5 of them joined the Confederate army. Richard Williams wasted no time and joined on November 7. Was Company I infiltrated by the rebels?

1<sup>st</sup> Sgt. Richard Dempsey of the 121<sup>st</sup> Pennsylvania tallies 840 Union soldiers who went over to the Confederate armies between November 28 and December 14. He is very specific in his count and explicit that they enlisted in order to escape "misery" and "the horrors of cold and starvation." [ Survivors' Association, History 121<sup>st</sup> Regiment Pennsylvania Volunteers, (Philadelphia, PA: Press of Catholic Standard and Times, 1906 ) pp.174-193 ] Dempsey stopped counting after December 14.

2 Sixty-niners from Company C also joined the Rebels. And within this roster there is the curious observation that "*sent to Salisbury, NC., November 4, 1864*" that applies to 12 names, the majority of them followed by "*absent at muster out of company*" or "*no further record.*" What's more puzzling is that 11 of those have no pension applications. Is this phrase a way of defining soldiers who were suspected of joining the Rebels at Salisbury, but it could not be proven? By Confederate statistics found in the Official Records [ Series 2, Vol. 8, p. 254 ], the First Foreign Battalion recruited 653; Major Andrews' Battalion got 677 and General York's got 407, for a total of 1, 737 out of over 10,321 counted at the prison on February 1, 1865. Even if this count is accurate, it is probably low in the overall numbers of men who took the Confederate way out, given Sgt. Demsey's pre-December 14 count as mentioned above.

By February 19, 1865, Salisbury was preparing to empty ahead of a general exchange of prisoners by both sides.

I count only 16 men who died at Salisbury proper with 5 following shortly after release. This is a very low percentage of deaths, even if only 100 men were actually sent to Salisbury, for example. Most amazingly, out of 19 men of Company G, 14 survived and only 2 died at the prison, 1 died on furlough, and 2 others are missing with no further records.

However, there are many Sixty-niners unaccounted for. Around 18 are absent, sick in hospitals or otherwise, at muster out along with 15 who are missing for other reasons. Unfortunately, this injects much uncertainty into this study. And I can find no man who died at Annapolis hospitals after release. This is also puzzling although it may be that some went to Wilmington, Baltimore, or St. Johns hospital at Annapolis where records are more scant on-line. Another mystery is why are 11 of those who are described as "missing in action" from the night of October 30 are all from Co. H?

The fact that there are so few pensions filed for here may be explained by the relatively short amount of time the Sixty-niners were held at Salisbury—around 4 to 5 months. Post-war, this was not enough to qualify for a pension if no cause for disability was documented

by a physician, even if, in fact, that amount of time was enough to kill around half of those captured in late September and October 1864.

Company H----11 MIA, 2 NFR, 11 died at Salisbury, 12 survived, and 4 men are noted as being at Salisbury on November 4 with no further record. Corporal John Scott is noted as wounded and not taken captive. Lt. Henry McQuade, Co. C, returns from capture in February to take command of Co. H as its captain. Sgt. McGrath, of Co. C also, returns in February from his captivity to take position as 1<sup>st</sup> Lt. of Co. C. Robert McKinley, first sergeant of Co. C, also returns in February to become 2<sup>nd</sup> Lt. of Co. C. This small portrait is more like I usually find in these studies.

What I suspect this study suggests is the demoralization of a regiment gone into captivity at an inauspicious time. It suggests that many more than actually described here took the Rebel way out. Not all, but many men, were Irish immigrants. Not all, but many, were signed up for only one year's service. With so little time in the field before capture, why not save your skin in that way?

Perhaps those Sixty-niners captured at Reams Station on August 25 and suffering at Salisbury two months longer told the fresh fish to get out any way they could?

Two names here may have been fatalities from the Confederate suppression of the Thanksgiving uprising at Salisbury where cannon was fired into the stockade (and potshots taken at men huddling in their burrows, according to some accounts). Louis Brown's list has 70 New Yorkers alone who died at Salisbury between November 25 and November 30, Frank Cole, William Darling, J. O'Brien, and Robert Smith, among them.

No doubt, other individuals might arrive at other conclusions than this. This awaits more information to come to the surface in the future. Please take note of my study of the 111<sup>th</sup> New York captured at the same time at this website.

Lest we forget, the 69th New York, at Antietam, lost 61.8 per cent. And charged into the Wheatfield at Gettysburg on July 2, 1863 where John Cranny and Thomas McGrath were both wounded.

BALDWIN, PHILIP.— Age, 38 years. Enlisted at New York city to serve three years, and mustered in as private, Co. C, July 14, 1864; captured, August 25, 1864; died, November 8, 1864, at Salisbury, N. C. ; also borne as Joseph Baldwin. [ IN Brown as Baldwin, P., Pvt., C, 69th NY, 11-8-64 ]

BENNETT, JOSEPH. — Age, 41 years. Enlisted at Brooklyn, to serve three years, and mustered in as private, Co. C, July 11, 1864; captured in action at Ream's Station, Va., August 25, 1864; paroled, no date; absent, sick, at muster-out of company. [ Died at home on furlough, a paroled POW, of consumption on November 28, 1864 after 26 days of freedom ]

BURKE, JOHN M.—Age, 30 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. K, April 5, 1864; wounded) and captured in action. May 5, 1864, at the Wilderness, Va.; died of disease, August 10, 1864, in prison at Andersonville, Ga.

DOYLE, DENNIS. — Age, 19 years. Enlisted, October 20, 1861, at Syracuse, to serve three years; mustered in as private, Co. K , November 17, 1861; transferred to Co. A, June 12, 1863; promoted corporal, no date; killed in action, July 2, 1863, at Gettysburg, P a . ; also borne as Doyal and David Doyle. [ IN Brown list as died at Salisbury on December 12, 1864 ]

EGAN, WILLIAM. — Age, 33 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. K , March 11, 1864; captured in action, August 25, 1864, at Ream's Station, Va. ; died, November 18, 1864, at Salisbury, N. C. [ IN Brown as Agan, Wm., Pvt., K, 69th NY, 11-19-64 ]

FARRINGTON, GEORGE. — Age, 30 years. Enlisted at New York city, to serve three years, and mustered in as private, .Co. F, July 27, 1864 ; captured in action, August 25, 1864, at Ream's Station, Va. ; died of disease, October 23, 1864, at Salisbury, N. C. ; also borne as Farrangton. [ IN Brown as Farrington, Geo., Pvt., F, 69th NY, 10-22-64 ]

FISHER, HENRY C. — Age, 19 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. A , February 3, 1864; captured in action, May 12, 1864, at Cold Harbor, Va ; died, January 28, 1865, at Andersonville, Ga. [ See Fisher, C. died October 4, 1864 at Salisbury ]

GRAHAM, JOHN. — Age, 25 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. K, March 17 , 1864; capture, June 22, 1864; died of disease, December 14, 1864, at Salisbury, N . C. [ IN Brown as Graham, John, Pvt., K, 60th NY, 12-14-64 ]

HEASTON, JAMES HENRY.—Age, 26 years. Enlisted at New York city, to serve three years, and mustered in as private, unassigned, March 12, 1864; never joined regiment; also borne as Heuston. [ Possibly on Brown list as J.H. Easton, died January 5, 1865 at Salisbury ]

HIGGINS, WILLIAM.— Age, 21 years. Enlisted, November 19, 1861, at Philadelphia, to serve three years; mustered in as private, Co. K, December 20, 1861; transferred to Co. A, June 12, 1863; to Co. F in January or February, 1864; re-enlisted as a veteran, February 22, 1864; captured in action, August 25, 1864, at Ream's Station, Va.; **paroled, March 1, 1865; died, April 4, 1865, while on furlough**; also borne as Higgin, and William Higgins, No. 2,

HOGAN, JAMES. — Age, 44 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. K , March 15, 1864; captured, August 25, 1864, near Petersburg, Va. ; **died of disease, March 4, 1865, while prisoner of war**; place not stated.

KEEFE, DANIEL.— Age, 30 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. A, June 30, 1864; captured in action, August 25, 1864, near Petersburg, Va.; **died, January 30, 1865, at Salisbury, N. C.**; also borne as O'Keefe. [ **IN Brown as Keath, Daniel, Pvt., A, 69th NY, 1-30-65** ]

KESSLER, GEORGE. — Age, 43 years. Enlisted at Brooklyn, to serve three years, and mustered in as private, Co. C, January 19, 1864; captured in action, August 25, 1864, at Ream's Station, Va. ; **died, December 10, 1864, at Salisbury, N. C** ; also .borne as George W. Keesler. [ **IN Brown as Keysler, George, Pvt., C, 69th NY, 12-10-64** ]

McCAFFREY, PATRICK.— Age, 26 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. K, February 3, 1864; captured in action, August 25, 1864, at Ream's Station, Va.; *sent to Salisbury, N.C., October 9, 1864, and absent at muster-out of company*; also borne as McCaffery and McCaffree.

McCORMICK, JOSEPH.— Age, 27 years. Enlisted at New York city, to serve three years, and mustered in as private, unassigned, July 20, 1864; captured in action, August 25, 1864, at Ream's Station, Va.; **died in prison, December 8, 1864, at Salisbury, N.C.** ; also borne as James McCormack. [ **IN Brown as McConnick, K., Pvt., B, 69th NY, 12-8-64** ]

McLOUGHLIN, JOHN.— Age, 20 years. Enlisted, January 25, 1864, at Brooklyn, to serve three years; mustered in as private, Co. C, January 28, 1864; captured, May 12, 1864, at Spotsylvania, Va.; **died, October 29, 1864, at Salisbury, N. C** ; also borne as McLaughlin. [ **IN Brown as McLaughlin, Jno., Pvt., E, 69th NY, 10-29-64** ]

SHARP, RICHARD.—Age, 31 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. E, October 22, 1861; transferred to Co. B, June 12, 1863; re-enlisted as a veteran, December 22, 1863; promoted corporal, no date; captured in action, August 25, 1864, at Ream's Station, Va.; **died, October 17, 1864, in hospital, Salisbury, N. C** ; also borne as Sharpe. [ **IN Brown as Sharpe, Richard, ---, B, 69th NY, 10-16-64** ]

SHERLOCK, JEREMIAH.—Age, 21 years. Enlisted at New

York city, to serve three years, and mustered in as/private, Co. K, June 25, 1864; captured in action, August 25, 1864, at Ream's Station, Va.; *sent to Salisbury, N.C. , October 9, 1864; absent at muster-out of company*; also borne as Sharlock.

SMITH, HUGH. — Age, 26 years. Enlisted, October 8, 1861, at New York city, to serve three years; mustered in as private, Co. I, October 30, 1861; wounded in action, December 13, 1862, at Fredericksburg, Va.; transferred to Co. B, Nineteenth Regiment, Veteran Reserve Corps, no date; retransferred to Co. I, June 14, 1864; transferred to Co. B and promoted corporal, no dates; captured in action, August 25, 1864, at Ream's Station, Va.; died, October 20, 1864, at Salisbury, N. C. [Possibly in Brown as Smith, H., ---, E, 69th NY, 3-20-65]

SULLIVAN, MICHAEL—Age, 41 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. K, April 4, 1864; wounded and captured in action, May 10, 1864, at Spotsylvania, Va.; died of disease, August 18, 1864, at Andersonville, Ga.
