This document provides guidance on:

- 1. Procurement of ACU uniforms by individual soldiers from online vendors.
2. Adherence to standards
3. Wear out and transition guidance

1. Procurement (Individual Purchase)

Get the FULL NYG 1334.2 Directive regarding this uniform by clicking HERE.

Please be advised—you are NOT required to purchase from the vendors listed in this document. However, unauthorized uniforms / accessories may not be worn with the NY Guard uniform. There are MANY cheap brands available on the internet that do NOT meet NY Guard requirements. It is each soldier's responsibility to ensure that all items he/she is wearing meets all requirements as per Directive 1334.2. Variance from this Directive will not be permitted. NO exceptions.

- A. Jackets: Proper on AMAZON, TRU-Spec on AMAZON. Note on Jackets—IR Tabs must be removed...
B. Trousers: Proper on AMAZON, TRU-Spec on AMAZON. Note on Trousers—IR Tabs must be removed...
C. T-shirts: AMAZON, US Cavalry. Note on T-Shirts—The ACU "Combat Shirt"...
D. Belts: SupplyCaptain.com, TRU-Spec on US Cavalry. Note on Belts— If color selection necessary...
E. Boots—Boots present more options than the jackets and trousers. Review uniform directive NYG 1334.2...
F. NameTapes / NY Guard Tapes —Nametapes and New York Guard tapes MUST be SEWN on. No exceptions...
G. SSI, Flag, and Rank Patches—SSI (NY Guard crest for left shoulder), NY State Flag, and Rank Patches may be affixed with Velcro...
H. Badges— G-4 is currently arranging new production on NYG Qualification badges. Only black-metal badges are authorized...
I. Patrol Cap— Currently, Ranger Joes is the only vendor carrying the authorized Patrol Cap.

Additional vendors that may carry correct items: Bradleys, US Cavalry, US Patriot, VT Army Navy, Ranger Joes, A-N Superstores, Uncle Sam's.

NYG Personnel may also purchase uniform items at the West Point and Fort Hamilton PX 's. NYG personnel may only purchase uniform items at the PX's, must be dressed in civilian clothing while shopping on post, and must be carrying NY Guard ID card for purchases.

2. Adherence to Standards

For individual purchases, it is absolutely essential to adhere to standards. NYGD 1338.2 provides the necessary guidance.

Reminder: Berets are NOT authorized for the NYG ACU uniform. Digital ACU Caps are NOT authorized. Digital Camo-backed nametapes are NOT authorized. Nametapes/NY Guard Tapes affixed by Velcro are NOT authorized.

3. Wear out and transition guidance

- A. The woodland camouflage pattern, also known as the Army Battle Dress Uniform (BDU) will no longer be authorized for wear as of 30 September 2013. BDUs are authorized for wear through that date.
B. Universal camouflage pattern items from the new NYG Utility Uniform are not authorized to be worn with the woodland camouflage pattern jacket and trousers.
C. New Army Combat Boots - (hot weather and temperate weather), made of tan rough side out cattle hide leather...
D. The Field Jacket (M65) woodland camouflage pattern, also known as the Army Battle Dress Uniform (BDU) Field Jacket...
E. The Parka, cold weather, woodland camouflage pattern, also known as the Army Battle Dress Uniform (BDU) Parka...
F. There is no wear out date for the Black fleece jacket, or OD/BDU Field gear, and these are authorized for wear with utility uniform until a wear out date is published.
