## We welcome our new Deputy Commander, Captain William E. Pries.

In a brief ceremony held on 10 June 2011 at Camp Smith, Captain Bill Pries assumed duties as my Deputy Commander, New York Naval Militia; from retiring Rear Admiral John Ingram.



Captain Bill Pries is a native of New York City. He is a graduate of Fordham University, and received his Juris Doctor degree from St. John's University School of Law.

In 1973, he received a direct commission into the United States Navy, and served as defense counsel at Commander, U.S. Naval Forces Japan in Yokosuka; and then as trial counsel, foreign criminal jurisdiction officer, and *ad hoc* military judge at Naval Legal Service Office Yokosuka through 1976. He then transferred to Italy, serving as senior defense counsel, senior trial counsel, and foreign criminal jurisdiction officer at Naval Legal Service Office Naples.

In 1980, he transferred to the inactive Reserve, serving in various capacities as executive officer and commanding officer of units supporting the International Law and Criminal Law Divisions of the Office of the Judge Advocate General. He also served as Staff Judge Advocate to Commander, Naval Reserve Readiness Command Region TWO, and later as Staff Judge Advocate to the Naval Space Command in Dahlgren, VA.

Captain Pries was promoted in the United States Navy to his current rank of Captain, in May 1991.

Captain Pries was the founding Commanding Officer of the elite unit supporting the Oceans Law and Policy Department of the Naval War College in Newport, RI. He served as a member of the Crisis Action Teams at U.S. European Command in support of Operation Allied Force (NATO bombing campaign in Kosovo), and at U.S. Joint Forces Command in the immediate aftermath of the 9/11 attacks on the World Trade Center and the Pentagon. He was recalled to extended active duty in 2002 as Deputy Legal Counsel for Operational Law to the Chairman, Joint Chiefs of Staff, until his mandatory retirement from the United States Navy.

Affiliating with the New York Naval Militia shortly after joining the Naval Reserve, he has most recently served as Senior Legal Advisor to the Commander.

Captain Pries' personal decorations include the Meritorious Service Medal (two awards), the Joint Service Commendation Medal, the Navy Commendation Medal, and the Navy Achievement Medal.

He is married to the former Kathleen Gallagher of New York City. They live in Brookville on Long Island.

# The Outgoing Deputy Commander RDML John G. Ingram



Rear Admiral Ingram's distinguished New York Naval Militia career spanned more than 44 years of service in ever demanding positions of increasing responsibility. As Deputy Commander, he oversaw tremendous changes and improvements in the management and functioning of this State Defense Force.

Rear Admiral Ingram was instrumental in the creation of viable and lasting operational partnerships with numerous federal, state, and local agencies that have furthered the effectiveness and responsiveness of the Naval Militia. He was critical to the nationally acclaimed cooperation between the New York State Division of Military and Naval Affairs, and United States Coast Guard Sector New York. As a result of his efforts, the United States Department of Homeland Security routinely relies on New York Naval Militia assets in order to complete federally assigned missions in the Port of New York and New Jersey. Furthermore, he was instrumental in the Naval Militia becoming integrated into all six of New York State's Joint Task Forces.

Rear Admiral Ingram ensured New York Naval Militia contributions were highlighted in media thereby

increasing public awareness of the naval component of the New York Military Forces. As Deputy Commander, he oversaw Naval Militia efforts in the post-crash events of USAir Flight 1549, the "Miracle on the Hudson." During this response, the New York Naval Militia Patrol Boat 440 was the only New York State asset on the water assisting with rescue and recovery operations.

Rear Admiral Ingram provided essential leadership for the Naval Militia through his role in statutory and regulatory administrative processes. He chaired numerous promotion and awards boards and guided the revision of force regulations and instructions.

Rear Admiral Ingram carried his responsibilities with distinction during this critical period in New York State history. His dedication to duty reflected great credit upon himself and was in keeping with the highest traditions of the sea services of the United States.

Admiral Ingram continues his service to the state as a Superior Court Judge in Brooklyn.

#### Meet Katharine Keller

At one time or another, you've probably had the need to speak with Katharine. Need educational

benefits information? A NYNM ID Card? Bridge passes?

Katharine started working in the Naval Militia Office at Division of Military and Naval Affairs Headquarters in Latham, NY on 29 August 2005.

Mrs. Keller is the Office Manager and is responsible for the day to day administration of the office, to include: entering new enlistments in to the data base, keeping the data base updated, and supplies all the units in the state with Bridge/Tunnel and Thruway passes for their Federal drill weekends. She also handles the fiscal responsibilities in the office.

Administering Education Benefits to the Navy, Marine and Coast Guard reservists that are members of the Naval Militia is her main duty and includes accepting the applications, ensuring that they are complete with signatures from the members command and that they have applied for their federal and state required grants as well. This information is then entered in to a state data base that is updated each semester. It is Mrs. Keller's responsibility to ensure that this information is correct and completed by the proper state deadlines so that the members receive their tuition reimbursement in a timely manner. She is married for 26 years to James Keller Jr., a Navy veteran and member of the NY Naval Militia, and has 3 children. Katharine M. Keller is a resident of Delmar, New York.

#### Master Gunnery Sergeant Frederick W. Green



Fred Green assumed the duties as Command Master Gunnery Sergeant, New York Naval Militia, in June, 2011. He advises the Commander on all enlisted personnel matters and is the senior enlisted representative for Navy, Marine Corps and Coast Guard Reservists affiliated with the Naval Militia.

Enlisting in the United States Marine Corps in 1966, he subsequently graduated from Communications School, and deployed to Chu Lia, Republic of Viet Nam. He served two tours and participated in 10 operations throughout the North sector of Viet Nam. He received the Purple Heart for actions during Operation Union II, in the Quang Tin Valley, in 1967.

After being honorably discharged from active duty in 1970, he joined 6th Communication Battalion to continue in the Marine Corps Reserves. In December 2001, he was ordered back to active duty and deployed to the Middle East to participate in Operations Desert Shield and Desert Storm. During this tour of duty in Saudi Arabia he was recognized for exceptional work as the Senior Technical Controller, supporting the largest Marine Corps communication network, including satellite, microwave, HF, VHF, digital-analog telephone switch and LAN/secure date links. In conjunction, he assumed duties as the Military Auxiliary Radio System (MARS) Coordi-

nator, providing Navy and Marine Corps personnel the ability to call home via single channel HF radio equipment.

He retired after 30 years from the United States Marine Corps in the rank of Master Gunnery Sergeant. He affiliated with the New York Naval Militia in May 1981.

His personal awards include the Purple Heart, Navy and Marine Corps Achievement Medal (three awards), Combat Action ribbon (two awards), Presidential Unit Citation-Navy, and numerous unit, campaign and service awards. Command Master Gunnery Sergeant Green is a graduate of Westchester Community College and Pace University. He is currently employed as the Supervisor of the Katonah office of the United States Postal Service.

He lives in Mahopac, NY, is married and has two daughters.

#### **ASK THE BRASS**

QUES: I was active duty in the USNR for 2 years and was informed to earn the Good Conduct Medal you need 4 years of active duty. I've been told there is no Good Conduct for 2 year Naval Reserve. Can I obtain the Good Conduct Medal in the NYNM?

REP: A Good Conduct Medal must be earned while in the USN, USNR, Marine Corps or Coast Guard.

The New York Naval Militia awards the Long and Faithful Service Ribbon after five years of service if the standard requirements have been met.

QUES: How do I train to qualify for MEBS crew here on Long Island, and if qualified will I have an opportunity to serve on a NYNM vessel?

REP: We are working to extend our small boat program onto Long Island. I am in the process of stationing PB 230 there.

If you are not a member of the Military Emergency Boat Service (MEBS), then you need to fill out NYNMFORM 1155 found on the website. Provide all supporting information for previously earned boating qualifications. Fax it all to HQ at 518 786 4427. More information on training requirements can be found in NYNMINST 1550.1, the MEBS Training Manual.

If you are a Long Island member of MEBS, let me know of your interest in conducting proficiency training in the area. Note that nearly all training is conducted in a non-pay volunteer status. We can issue military SAD orders if you are eligible for them at your place of employment.

Opportunities for paid orders are very limited, and generally involve operational support to other agencies, such as the Coast Guard.

NOTE: with the current fiscal restraints in NYS, State Active Duty (SAD) orders for training are only in a non-pay status. However, the orders are usually eligible for military leave from your place of employment.

#### Let's Be Professional Out There!

Coxswains, you are in charge of the boat, and it is imperative that you represent the Naval Militia in a positive way. Your appearance, that of your crew, and your boat are all part of it.

Make sure your crew is properly attired with the right boots, hats, and uniform pieces. Wear your uniform with pride.

When the boat is underway, make sure all fenders are taken in, along with all lines, and flags flying properly. Stow non-essential gear. Remember, keep it "SHIP SHAPE."
