ADAMS, PETER.—Age, 18 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. K , November 11, 1861; promoted corporal and returned to ranks, no dates; promoted sergeant, June 10, 1864; **wounded in action, August 14, 1864, at Strawberry Plains, Va.**; mustered out, December 2, 1864, at Elmira, N . Y . [**Noted as slightly wounded by *Express* newspaper, Had wound dressed and rejoined company**] [**Died January 4, 1921 at Batavia, NY**]

BAKER, ALBERT H.—Age, 19 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. K, March 3, 1864; promoted corporal, April 21, 1865; sergeant, June 10, 1865; mustered out with company, August 28, 1865, at Richmond, Va. [**Listed as missing in *Express* newspaper casualty list?**] No Pension Application Found/NPAF]

BAKER, JOHN.—Age, 45 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. K, August 25, 1862; mustered out with detachment, June 27, 1865, at Mower Hospital, Philadelphia, Pa .; prior service, Co. K, First New York Volunteers, Mexican War. [**Listed as missing in *Express* newspaper casualty list?**] [**Died in 1902**]

BAKER, WILLIAM W.—Age, 38 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. F, March 5, 1861; captured in action, August 16, 1864, at Strawberry Plains, Va.; **died, while a prisoner of war, November 30, 1864, at Salisbury, N . C.**; also borne as Barker. [**Widow applies for pension on June 5, 1865**] [**IN Louis Brown's list of New Yorkers who died at Salisbury as Baker, W.W., Pvt., F, 100th NY, 12-1-64**]

BRICE, DANIEL.—Age, 30 years. Enlisted, October 8, 1861, at Buffalo, to serve three years; mustered in as corporal, Co. E , October 9, 1861; returned to ranks, no date; captured in action, July 18, 1863, at Morris Island, S. C.; paroled, no date; again **captured in action, August 16, 1864**, at Strawberry

Plains, Va .; paroled, no date; mustered out, December 19,1864, at Rochester, N. Y. [Died November 22, 1895]

BROOKS, MICHAEL.—Age, 30 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. C, March 3, 1864; **wounded and captured in action, August 16, 1864**, at Strawberry Plains, Va.; paroled, no date; transferred to Co. G, Nineteenth Regiment, Veteran Reserve Corps, no date; mustered out with detachment, September 5, 1865, at Buffalo,N.Y.[Died around March 1879 ?]

BROWN, JOHN.—Age, 21 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. K, October 22, 1861; **wounded in action, July 28, 1864, at Deep Bottom, Va.**; mustered out, February 13, 1864, at Elmira, N. Y .[**Newspaper article says, “knee, severely.”**] [Invalidated in March 1865; no death date given]

????BROWN, LEWIS.—Age, 24 years Enlisted, November 21, 1861, at Grand Island, to serve three years; mustered in as private, Co. D, December 23, 1861; **captured in action, May 16, 1864, at Drewrys Bluff, Va.**; paroled, no date; mustered out, March 31, 1865, at Rochester, N. Y .[**According to Express newspaper casualty list, he was missing in action at Four Mile Creek on August 14 or 16**] [Died around August 1891 ?]

BUDD, HENRY.—Age, 29 years. Enlisted at Maine, to serve one year, and mustered in as private, Co. A, July 17, 1863; **wounded in action, August 16, 1864, at Deep Bottom, Va.; discharged for wounds, July 22, 1865, at hospital, Fortress Monroe, Va.**[Invalidated in May 1866; father applies for pension that is not granted.]

CAMPBELL, WILLIAM.—Age, 24 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. C, February 17, 1864; **captured in action, August 16, 1864**, at Deep Run, Va.; **no further record.** [NO Pension Application Found/ NPAF]

CASEY, FRANK.—Age, 18 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. H , September 4, 1862; promoted corporal, July 18, 1863; **wounded in action, August 16, 1864, at Deep Bottom, Va.**; promoted sergeant, September 1, 1864; first sergeant, December 3, 1864; mustered out with detachment, June 15, 1865, at Richmond, Va. Commissioned, not mustered, second lieutenant, May 31, 1865, with rank from March 11, 1865, vice W. O. Barthaner, mustered out.[died November 27, 1919 at Bradford, PA]

CASEY, MICHAEL.—Age, 32 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. C, March 3, 1864; captured in action, August 16, 1864, at Deep Run, Va.; died of disease, while a prisoner of war, December 24, 1864, at Salisbury, N. C. [NPAF] [IN Brown as Casey, Michael, Pvt., C, 100th NY, 12-24-64]

CHARLSON, JONAS.—Age, 22 years. Enlisted at Brocton, to serve three years, and mustered in as private, Co. E, November 1, 1861; captured in action, May 31, 1862, at Fair Oaks, Va.; paroled, no date; promoted corporal, no date; wounded in action, August 16, 1864, at Strawberry Plains, Va.; mustered out, October 19, 1864, at Elmira, N.Y. [CARLSON—died January 20, 1925 at Vineyard, NJ]

CLYNCH, RICHARD.—Age, 26 years. Enlisted at Buffalo, to serve three years, and mustered in as corporal, Co. F, February 22, 1864; killed in action, August 16, 1864, at Deep Bottom, Va.; also borne as Clinch and Clench. [Widow applies in January 1867]

CONNOLLY, PATRICK I.—Age, 21 years. Enrolled at Rochester, to serve three years, and mustered in as private, Co. C, November 27, 1861; promoted corporal, no date; sergeant, March 1, 1863; mustered in as second lieutenant, January 1, 1865; as captain, Co. I, April 18, 1865; mustered out with company, August 28, 1865, at Richmond, Va.; also borne as Conley and Conly. Commissioned second lieutenant, December 7, 1864, with rank from November 5, 1864, vice S. W. Babbitt, discharged; captain, March 30, 1865, with rank from March 6, 1865, vice F. C. Brunck, mustered out. [Noted as wounded by *Express newspaper*] [NPAF]

COONS, HENRY.—Age, 26 years. Enlisted, December 9, 1861, at Buffalo, to serve three years, and mustered in as private, Co. A, December 10, 1861; transferred to Co. K, in January, 1862; re-enlisted as a veteran, January 15, 1864; wounded, September 8, 1864, near Petersburg, Va.; died of his wounds, January 25, 1865, in hospital, Fortress Monroe, Va. [Listed as missing by *Express newspaper*] [Widow and minor apply in March 1865]

COOPER, WILLIAM.—Age, 30 years. Enlisted at Watertown, to serve three years, and mustered in as corporal, Co. B, October 5, 1863; captured in action, August 16, 1864, at Deep Bottom, Va.; sent to Salisbury, N.C., October 9, 1864; died, about January 15, 1865, of typhoid pneumonia, at same place; prior service in Co. G, Ninety-fourth Infantry. [Widow applies on July 14, 1865] [NOT found in Brown's list] COOPER, WILLIAM.—Age, 40 years. Enlisted, January 11, 1862, at Watertown, to serve three years; mustered in as private, Co. G, February 13, 1862; discharged, January 13, 1863;

subsequent service in One Hundredth Infantry.

COULTER, GEORGE.—Age, 42 years. Enlisted at Thirtieth Congressional District, to serve three years, and mustered in as private, Co. C, August 15, 1863; wounded in action, September 18, 1864, near Petersburg, Va.; discharged, June 17, 1865, at Baltimore, Md. [**Noted as wounded at Four Mile Run in *Express* newspaper**] [Died March 23, 1895 at “Forest” Ontario, Canada]

CRANDALL, RICHARD.—Age, 35 years. Enlisted, September 7, 1863, at Norwich to serve three years; mustered in as private, Co. D, October 7, 1863; discharged, to date August 20, 1865. [**Noted as wounded by *Express* newspaper**] [Died May 24, 1916 in Otsego County, NY]

CRUTHERS, EDWARD L.—Age, 22 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. D, August 30, 1862; captured in action, August 16, 1864, at Deep Bottom, Va.; **absent, in prison, at Salisbury, N.C., October 9, 1864; no further record;** also borne as Crothers and Crotters. [NPAF] [NOT found in Brown]

DASHBRO, JOHN.—Age, 34 years. Enlisted, September 28, 1861, at Brocton, to serve three years; mustered in as private, Co. E , November 1, 1861; promoted corporal, April 14, 1862; sergeant, August 1, 1863; re-enlisted as a veteran, January 15, 1864; **captured in action, August 16, 1864,** at Strawberry Plains, Va.; paroled, no date; promoted commissary sergeant, June 15, 1865; deserted, August 8, 1865; also borne as Besbro and Disbrow. [NPAF]

EDDY, CHARLES D.—Age, 18 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. K , December 3, 1861; promoted corporal, and mustered out with detachment, October 25, 1864, at Buffalo, N , Y . [**Listed as missing by *Express* newspaper**] [Appears to have died around November 1890]

ELY, JR., SAMUEL.—Age, 26 years. Enrolled at Buffalo, to serve three years, and mustered in as private, Co. K , September 2, 1862; promoted sergeant, August 4, 1863; **first sergeant,** November 18, 1863; mustered in as second lieutenant, Co. B, November 5, 1864; as first lieutenant, Co. D, December 3, 1864; as captain, March 11, 1865; mustered out with company, August 28, 1865, at Richmond, Va.; also borne as Eley.
Commissioned second lieutenant, November 19, 1864, with rank from November 5, 1864, vice E. L. Cook, promoted; first lieutenant, January 20, 1865, with rank from December 3, 1864,

vice D. M. White, not mustered; captain, May 31, 1865, with rank from March 11, 1865, vice W. Granger, Jr., promoted. [*Noted as slightly wounded by Express newspaper; in another article this characterization of his wound is repeated.*] [Applies as an invalid in June 1880; widow applies---neither granted; no death date given]

EVERT, LEOPOLD.—Age, 22 years. Enrolled at Buffalo, to serve three years, and mustered in as first sergeant, Co. C, September 25, 1861; promoted second lieutenant, July 25, 1862; first lieutenant, November 15, 1862; mustered in as **captain, May 10, 1863; dismissed, September 2, 1864; dismissal revoked, October 16, 1865**, and honorably discharged, to date September 2, 1864; also borne as Evert.

Commissioned second lieutenant, September 13, 1862, with rank from July 25, 1862, vice Louis H. Todd, resigned; first lieutenant, December 22, 1862, with rank from November 15, 1862, vice William Noble, discharged; captain, April 18, 1863, with rank from March 6, 1863, vice J. Nicholson, resigned. [*Noted as sunstruck by Express newspaper*] [*appears to have died around June 1891*]

FIERKE, AUGUST.—Age, 31 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. F, August 4, 1862; *wounded in action, August 16, 1864, at Deep Run, Va.; discharged for disability caused from wounds, June 26, 1865, at Baltimore, Md.*; also borne as Fleikie and Fearke. [Invalided in August 1865; no death date given]

FISCHBACK, BERNHARDT.—Age, 28 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. F, December 13, 1861; captured in action, May 31, 1862, at Fair Oaks, Va.; paroled, no date; promoted corporal, August 18, 1863; re-enlisted as a veteran, January 15, 1864; *wounded in action, August 16, 1864, at Deep Run, Va.*; promoted sergeant, November 6, 1864; wounded in action, April 2, 1865, at Fort Gregg, Va.; mustered out with company, August 28, 1865, at Richmond, Va. [Invalided in April 1870; no death date given]

FITZGERALD, MILTON D.—Age, 19 years. Enlisted at Syracuse, to serve three years, and mustered in as private, Co. E, August 29, 1861; *captured in action, August 16, 1864*, at Deep Run, Va.; paroled, no date; mustered out with company, August 28, 1865, at Richmond, Va. [Died May 29, 1915 at Stafford, NY]

FRIEDMAN, JACOB.—Age, 35 years. Enlisted, November 10, 1861, at Springville, to serve three years; mustered in as private, Co. A, November 26, 1861; re-enlisted as a veteran, January 15, 1864; missing in action, August 15, 1864, at Deep Run, Va.; *died, August, 1864, at Andersonville, Ga.*; also borne as

Freedman, [38 pages at www.fold3.com of widow's pension. Frank Smith, Co. A, captured at Drewrys Bluff, attests to seeing Jacob at Andersonville and that he died there around September 1, 1864. This makes the case much more likely that Jacob was captured at Drewrys Bluff also, and was only discovered to be missing three months later. Despite the discrepancies the widow and three children were pensioned.]

GAGE, CHARLES C—Age, 22 years. Enlisted at Canandaigua, to serve three years, and mustered in as private, Co. H , October 7, 1863; mustered out with company, August 28, 1865, at Richmond, Va. [**Noted as wounded by *Express* newspaper**][Died August 21, 1913 at Dundee, NY]

GAGE, WILLIAM.—Age, 18 years. Enlisted, November 29, 1861, at Buffalo, to serve three years; mustered in as private, Co. C, November 30, 1861; promoted corporal, March 1, 1863; sergeant, October 20, 1863; **captured in action, May 16, 1864**, at Drewrys Bluff, Va .; paroled, no date; mustered out, May 16, 1865, at Elmira, N . Y. [**Listed in *Express* newspaper as missing in action at Four Mile Creek on August 14 or 16**] [Died February 11, 1913 at Plymouth, MI]

GAYLORD, JAMES S.—Age, 21 years. Enlisted at Springville, to serve three years, and mustered in as private, Co. A , November 5, 1861; promoted sergeant, no date; wounded in action, July 18, 1863, at Morris Island, S. C.; returned to ranks, no date; **wounded in action, July 28, 1864, at Deep Bottom, Va.**; discharged, January 3, 1865, at Buffalo, N.Y. [Invalided in May 1865; appears to have died shortly after]

GOETZ, ANDREW.—Age, 34 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. F , July 28, 1862; mustered out with detachment, June 15, 1865, at Richmond, Va.[**Noted as wounded in *Express* newspaper**][Died in 1912]

GRANGER, JR., WARREN.—Age, 20 years. Enrolled, September 23, 1861, at Buffalo, to serve three years; mustered in as second lieutenant, Co. K, January 7, 1862; as first lieutenant, May, 31, 1862; as **captain**, July 20, 1862; captured in action, August 16, 1864, at Strawberry Plains, Va .; paroled, February, 1865; mustered in **as lieutenant-colonel, May 17, 1865**; mustered out with regiment, August 28, 1865, at Richmond, Va. Commissioned second lieutenant, February 7, 1862, with rank from January 3, 1862, original; first lieutenant, June 20, 1862, with rank from May 31, 1862, vice John Wilkinson, killed in action; captain, August 13, 1862, with rank from July 20, 1862, vice Charles H . Hinshaw, resigned; lieutenant-colonel, May 11, 1865, with rank from March 11, 1865, vice L. S. Payne, discharged.[Died September 11, 1894 at Buffalo, NY]

GROWNEY, BARNEY.—Age, 24 years. Enlisted, October 14, 1861, at Bergen, to serve three years; mustered in as private, Co. B, October 16, 1861; promoted corporal, no date; Wounded, May 7, 1864, at Port Walthall, Va.; **captured in action, August 16, 1864**, at Deep Bottom, Va.; released, March 3, 1865, at Wilmington, N.C.; returned to ranks, no date; mustered out, May 20, 1865, at Rochester, N. Y .; also borne as Barnard Growney. [**Died August 28, 1923 at Le Roy, NY**]

HACKLE, JOHN.—Age, 31 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. F , March 11, 1861; **missing in action, August 16, 1864, at Deep Bottom, Va.;** **supposed to have been killed;** true name, John Baptiste Heckl.[Two fellow soldiers testify to seeing him fall in the battle, see www.fold3.com]

HANSS, FREDERICK. — Age, 29 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. A, December 16, 1861; **wounded, no date or place;** mustered out with detachment, January 30, 1865, at Buffalo, N . Y . ; also borne as Hantz.[**Noted as missing at Four Mile Run, name spelled as Hand or Rand**] [Died June 29, 1899]

HANOLD, PAUL.—Age, 22 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. E, September 27, 1861; captured in action, July 18, 1863, at Morris Island, S. C ; paroled, no date; **again captured, August 16, 1864**, at Deep Run, Va.; paroled, no date; mustered out, December 8, 1864, at Rochester, N . Y .; also borne as Honald and Honold. [Died March 11, 1915 at Buffalo, NY]

HETCHLER, SIMON.—Age, 21 years. Enlisted at Potter, to serve three years, and mustered in as private, Co. B, July 31, 1863; wounded, no date; discharged, May 31, 1865, at hospital, Fortress Monroe, Va.[**Noted as wounded by Express newspaper**] [Died February 5, 1913 at Hale, MI]

HIGGINS, THOMAS.—Age, 28 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. C, October 11, 1861; promoted corporal, January 2, 1864; re-enlisted as a veteran, January 15, 1864; captured in action, May 16, 1864, at Drewrys Bluff, Va.; **died of disease, February 11, 1865, at Salisbury, N. C.** [Was actually captured at Four Mile Creek on August 14 or 16 according to newspaper casualty list] [21 pages of widow's pension at www.fold3.com] [**IN Brown as Higgins, Thomas, Pvt., C, 100th NY, 2-10-65**]

HOLLER, STEPHEN.—Age, 14 years. Enlisted, February 19, 1862, at Buffalo, to serve three years; mustered in as private, Co. H , February 20, 1862; **wounded in action, August 31, 1862, at Fair Oaks, Va., and August 16, 1864, at Deep Run, Va.;** discharged for wounds, to date February 25, 1865, at Buffalo, N. Y .; also borne as Hollow. [Died December 26, 1881]

HOUGHTALING, JESSE.—Age, 37 years. Enlisted at Starkey, to serve three years, and mustered in as private, Co. H , July 31, 1863; **wounded in action, August 18, 1864, near Deep Run, Va.;** mustered out with company, August 28, 1865, at Richmond, Va.; also borne as Haughtaling. [Died 1889 at Dundee, NY]

HULL, GEORGE.—Age, 21 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. G, December 16, 1861; promoted corporal, no date; returned to ranks, August 30, 1863; again promoted corporal, no date; **killed in action, August 14, 1864, at Deep Run, Va.** [Father applies in August 1881]

JACKSON, JOHN.—Age, 23 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. A , December 10, 1863; mustered out with company, August 28, 1865, at Richmond, Va.[**Noted as wounded by *Express newspaper***][NPAF]

KANE, PATRICK.—Age, 21 years. Enlisted, December 20, 1861, at Buffalo, to serve three years; mustered in as private, Co. E, December 21, 1861; captured in action, May 31, 1862, at Fair Oaks, Va.; paroled, no date; **killed in action, August 16, 1864, at Deep Bottom, Va.;** also borne as Kain.[**Had been wounded in the side “slightly” on July 27, according to another newspaper item**][Died September 28, 1897]

KANELL, ISAAC—Age, 19 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. H , June 3, 1864; **wounded in action, August 16, 1864, at Deep Run, Va.;** mustered out with company, August 28, 1865, at Richmond, Va.[NPAF]

KELLY, PETER.—Age, 21 years. Enrolled, December 13, 1861, at Ogdensburg, to serve three years; mustered in as private, Co. A, December 23, 1861; re-enlisted as a veteran, and promoted corporal, January 15, 1864; promoted sergeant, September 26, 1864; first sergeant, May 23, 1865; mustered in as second lieutenant, July 4, 1865; mustered out with company, August 28, 1865, at Richmond, Va.
Commissioned second lieutenant, May 31, 1865, with rank from March 11, 1865, vice J . Pratt, promoted.[**Noted as wounded at Deep Bottom**][**Died October 17, 1921 at Staples, ????**]

KLINTZMANN, JOHN.—Age, 18 years. Enlisted at Silver Creek, to serve three years, and mustered in as private, Co. C, December 10, 1861; **captured in action, August 16, 1864**, at Deep Run, Va.; **no further record**; also borne as Klinzman. [KLINGMANN---Mother applies for pension in 1882]

KUHN, SIDNEY J.—Age, 24 years. Enlisted, February 1, 1862, at Buffalo, to serve three years; mustered in as sergeant, Co. A, February 1, 1862; **killed in action, August 16, 1864, at Deep Run, Va.** [NPAF]

LEE, JAMES.—Age, 31 years. Enlisted at Allegany, to serve three years, and mustered in as private, Co. A, August 23, 1863; promoted corporal, January 11, 1865; sergeant, May 22, 1865; mustered out with company, August 28, 1865, at Richmond, Va. [**Noted as wounded by *Express newspaper***] [Died December 14, 1894 at Stanton, MS]

MASON, GEORGE.—Age, 27 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. A, September 11, 1862; **wounded in action, August 11, 1864, at Deep Bottom, Va.**; discharged for wounds, February 22, 1865, at Chaffins Farm, Va. [NPAF]

McMANN, JOHN—Age, 25 years. Enrolled at Rochester, to serve three years, and mustered in as private, Co. C, November 27, 1861; promoted sergeant, March 26, 1862; first sergeant, no date; mustered in as second lieutenant, January 13, 1863; as first lieutenant, May 10, 1863; wounded in action, July 18, 1863, at Beauford, S. C.; mustered in as **captain, Co. B**, June 1, 1864; mustered out, to date March 6, 1865; also borne as MacMann. Commissioned second lieutenant, December 22, 1862-, with rank from November 15, 1862, vice L. Evert, promoted; first lieutenant, April 18, 1863, with rank from March 6, 1863, vice L. Evert, promoted; captain, May 18, 1864, with rank from April 21, 1864, vice M. H. Topping, resigned. [**Noted as wounded by *Express newspaper*; “slightly” in another article, and in another, “head, slightly”**] [Invalidated in June 1865; appears to have died around that time]

MITCHEL, FARL.—Age, 18 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. C, January 3, 1862; **captured in action, August 16, 1864**, at Deep Run, Va.; paroled, no date; mustered out with detachment, January 30, 1865, at Buffalo, N. Y. [Died December 20, 1928 at (illegible) Home, WI] [**Noted as wounded by *Express newspaper***] [**Died December 20, 1928 at National Home, WI**]

MORRIS, ERASTUS C—Age, 28 years. Enlisted at Canandaigua, to serve three years, and mustered in as private, Co. H , October 3, 1863; **wounded in action, August 16, 1864, at Deep Run, Va.**; mustered out with company, August 28, 1865, at Richmond, Va.; also borne as Menis.[died June 20, 1894]

MOWOT, DANIEL.—Age, 23 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. C, August 8, 1862; **wounded in action, July 27, 1864, at Deep Bottom, Va.; again, August 16, 1864, at Strawberry Plains, Va.; discharged for wounds, June 17, 1865, at hospital, Central Park, New York city** ; also borne as Mowatt.[Invalided in September 1865; died October 2, 1899]

MYERS, MARKS H.—Age, 18 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. F , June 15, 1863; **wounded in action, August 16, 1864, at Deep Bottom, Va.**; transferred to Co. I, Twentieth V. R. C. , no date; mustered out, September 5, 1865, at Wheeling, W. Va.[Invalided in October 1865; died in 1908]

E, December 3, 1861; absent, wounded, July 27, 1864; mustered out with detachment, January 30, 1865, at Buffalo, N. Y. ; also borne as Weigham and Weighand.[**Wounded severely in foot on July 27**] [**Died April 5, 1933 at Otto, NY**]

WEBBER, VALENTINE.—Age, 20 years. Enlisted at Buffalo, to serve three years, and mustered in as private, Co. B, September 13, 1862; mustered out with detachment, June 15, 1865, at Richmond, V a.; also borne as Weber. [**Wounded in the arm severely on July 27**] [Applies as an invalid in January 1887; no death date given]

WHITE, DAVID M.—Age, 24 years. Enrolled at Buffalo, to serve three years, and mustered in as private. Co. H , September 11, 1862; promoted corporal, January 7, 1868; sergeant, July 18, 1863; first sergeant, October 1, 1864; died of chronic diarrhea, December 3, 1864, at U. S. Hospital, Fortress Monroe, Va.

Commissioned, declined, first lieutenant, November 19, 1864, with rank from September 30, 1864, vice L. D. Homer, discharged.[**Noted as wounded by Express newspaper** [NPAF]

About 88 names here. Phisterer tallies 87 casualties for July 27 to August 18.

Approximately 22 names of those enlisted men captured at Deep Bottom in mid-August 1864. Of those, 5 men are listed as having died at a specific prison. An

additional 3 men are noted as captured but “no further record,” and only one of those is connected to a pension application.

About 9-14 men seem to have been temporarily missing in action.

Very few dates are given for paroles so it is possible that the majority of these men never went to Salisbury. Only Barney Gowney seems to have definitely survived Salisbury. Other men were released in October and November so it is unlikely they left the Richmond area. Nonetheless, if 9 men died of 22 captured, the death rate would still be slightly in excess of 40%. But the contrast between the death rate numbers of other regiments captured at Weldon Rail Road and Ream’s Station later in August---approaching 45% and over that in many instances---and these few men of the 100th NY is puzzling to some degree.

The statistics appear to be far grimmer for those 100th NY men captured in May 1864 and sent to Andersonville en masse but that study remains to be done

In all, about 51 men were wounded, died of wounds, were wounded seriously so as to not return, or killed in action from late July to mid-August, 1864:

DOW----2

SWIA----6

WIA---34

Sunstroke--- Capt. Evert, who seems to have had some difficulty with the higher-ups over that particular malady.

Phisterer counts 1 officer and 11 men KIA or DOW, along with 1 officer and 45 wounded. And 1 officer and 23 men “missing.” This study corresponds nearly exactly with Phisterer.

The newspaper articles indicate that author “R” of Company I thought “the boys” in good spirits after a successful flanking assault against Confederate lines and a battery of “four eight-inch seacoast howitzers” taken with a “small” loss “not exceeding 30.” General Hancock’s 2nd Corps had also taken back four 20-pound Parrots on the morning of the 27th of July---cannons that had been lost from the 10th Corps on May 16 at Drewry’s Bluff, where the 100th NY lost 230 men. Given that perspective, this is quite accurate on the part of author, “R.”

By September 27, 1864, their Colonel George B. Dandy was in Buffalo, NY, asking the Board of Trade to refill his ranks down from 830 men to 330 in the time he took command. “He said that the rebel armies were about exhausted, and that our armies, largely reinforced, would be enabled to finish the rebellion before this time next year.” Indeed, the 100th NY would go on to chase the Confederates towards Appomattox Courthouse the following April, taking 59 casualties from March 28 to April 9, 1865.

Bernhardt Fischback, Company F, would again be wounded at the taking of Fort Gregg on April 2, 1865.

Colonel George Dandy was brevetted for Fort Wagner, Deep Bottom, and Fort Gregg.

K , November 26, 1861; captured, October 8, 1864, before Richmond, V a . ; died of starvation, November 20, 1864, at Andersonville, Ga [IN Brown as Jones, ---, Pvt., ---, 100th NY, 12-18-64, Died at Salisbury][NPAF]
