MILITARY REQUIREMENTS AND OTHER SELECTIVE PLACEMENT FACTORS: This vacancy announcement is for Full Time National Guard Duty - Counterdrug (FTNGDCD) under Title 32 USC 112 Sec 502 (f). Length of tour is dependent upon funding and performance, but will not exceed 30 September 2025.

**BRIEF DESCRIPTION OF DUTIES:** Civil Operators will provide a strong response to substance abuse in each community by building effective local coalitions and supporting their implementation of evidence-based strategies. Civil Operations teams play a critical role in fostering an effective community-based response by using unique military skillsets to assist local coalitions in addressing substance use/abuse and assisting civil authorities to form and effectively lead community anti-drug coalitions. Operators will help local leaders form alliances and partnerships, enhance collaboration at the grass roots level, and strengthen planning and implementation with the overall goal of creating drugfree communities. Using unique military expertise, Civil Operators will assist coalitions to become more efficient, strategic, and successful. When a community has yet to form an organized coalition, Civil Operators will work with federal, state, and local entities to help create partnerships consisting of community sectors for the purpose of establishing a community coalition. The coalition shall, to the extent possible, be comprised of sector representation as outlined in The Drug-Free Communities Act of 1997, Section 1032, of Public Law 105-20, and Title 21 U.S. Code, Sections 1521-1535, as amended. Support to coalitions will include, but is not limited to: (a) Providing independent strategic leadership within a coalition to facilitate planning and development using military decision making methods to complement public health, prevention, and other models to create more effective partnerships. (b) Increase the capacity, sustainability, and effectiveness of coalitions and partnerships by taking an active role in coalition meetings, conferences, trainings, and events as a significant partner of the coalition (c) Provide support to coalitions. Support may include but is not limited to: operational, analytical, personnel, training, logistics, and administrative duties.

**ADDITIONAL POSITION INFORMATION:** Duties may require additional nights and weekends aside from unit training assemblies. Duty start date is dependent upon results of physical exam in accordance with AR 40-501, Chapter 3 and Chapter 10 and AFI 48-123, Chapter 3 and Attachments 2, 9 and 19.

- Resume of civilian and military skills.
- Last two physical fitness scores (one within last six months of start of orders).
- Verification of security clearance.
- Letter of Interest (LOI) explaining why you are interested in the Case Analyst Support position. (Articulate in your LOI if your unit of assignment is scheduled to deploy within the next 6 months, whether you are promoting with the next 6 months AND if you are attending any schools for longer than 30 days)

## **QUALIFICATIONS & REQUIREMENTS:**

- Individual must possess excellent communication and interpersonal skills; a strong sense of initiative; an ability to analyze vast amounts of information; an ability to think creatively, tactically and strategically; an ability to work independently; dedication to duty.
- Presentation/briefing experience; strong writing skills; an ability to learn quickly; good research skills; innate curiosity.
- A willingness to relocate to another part of New York State is a plus.

## ADDITIONAL INFORMATION:

- Personnel must be eligible for FTNGDCD IAW ARNG or ANG requirements.
- Personnel must receive a written recommendation from their unit representative or commander. (on page 2 of 10-8 application.)
- ARNG Personnel must meet medical retention standards as set forth in AR 40-501 Chapter 3 and Chapter 10.
- ANG personnel must meet the medical retention standards as set forth in AFI 48-123 Chapter 3 and Attachments 2, 9, and 19.
- Urinalysis testing is required upon entry on active duty and personnel are subject to periodic testing while on active duty. These requirements are in addition to testing by units of assignment during IDT/IAD under the JNGSAP.
- Requirement to continue attendance at IDT/IAD and AT while on FTNGDCD.
- Probability of criminal records check, and/or security screening will be conducted. Applicants will be informed that such inquiries are likely to be completed after entry on duty and that negative or unfavorable information received could result in their removal from the CD program.
- Standards of Conduct:
