Members of Title 32 duty are subject to the provisions of New York State Military Law. Individuals selected will participate with the unit of assignment during all periods of Unit Training Assemblies, Annual Training, deployments, special projects and exercises. NEW YORK ANG MEMBERSHIP IS REQUIRED.

## **FORCE SUPPORT CAREER FIELD**

### **Waiver Restrictions:**

Per the AFECD; 3F091, 3F191, 3F291, and 3F591 are feeder AFSCs for the Force Support Squadron Senior Enlisted Leader (FSS SEL) position. The incumbent must have one of the above AFSCs at the 9-skill level and be promotable to the grade of E-9 to be assigned to the FSS SEL duty position (DAFSC). Due to UTC requirements, duty position entry level waivers will not be considered.

No waiver is required for a service member with a valid feeder AFSC at the 9-skill level (3F091, 3F191, 3F291, and 3F591), however a MCR will need to be completed and submitted through the NGB/A1M MCR process to update the UMD to reflect the appropriately duty AFSC (3F000, 3F100, 3F200, 3F500).

### **Specialty Qualifications:**

3F0, 3F1, 3F2, and 3F5 AFSCs all have rank restrictions for entering the career field. Please review the appropriate AFECD section for each specific AFSC requirements.

**Members selected for the FSS SEL position that do not hold one of the feeder AFSCs at the 9-skill level cannot be placed in the duty position.** Please follow below steps in this situation:

1. Prior to finalizing the hiring, member must decide which of the feeder AFSCs to pursue. An entry level classification waiver package must be submitted.
2. If entry level requirements are waived, member can be placed in an appropriate duty position (not the FSS SEL position) and complete all upgrade requirements.
3. Once member has acquired a 9-level in one of the feeder AFSCs as listed above, they can be assigned to the FSS SEL duty position.

### **Mandatory Package Contents:**

None. Follow AFSC specific waiver requirements.
