Required Security Clearance: Secret clearance and must be able to obtain a **Top-Secret clearance**

Required Qualifications: MOS IMMATERIAL

Flexible, adaptable, and able to work under pressure. High attention to detail and the ability to multi-task. SM must be able to work with limited supervision and represent the team in a professional matter at ALL times. SM MUST be able to travel TDY on a regular basis. SM must always maintain in good standing with their M-Day unit. SMs with specific mission assurance experience and/or with collegiate degrees will get preference over all prospective candidates.

APPOINTMENT FACTORS: Applicants must be fully eligible to come on board on an ADOS tour (Title 32) as stated in AR 135-200. If selected, the same ADOS packet submitted for application must also be submitted via ETL for proper approval processing. Soldiers must not reach 18 years Active Federal Service (AFS) during this tour or reach mandatory removal from an active status based on age or service (without any extensions) under any provisions of law or regulation as prescribed in current directives.

DESCRIPTION OF DUTIES:

A Cyber Analyst on the Army Mission Assurance Assessment Team (AMAAT) supports the assessment of critical assets, systems, networks, and infrastructure to identify vulnerabilities that could impact mission-essential functions. The analyst evaluates cyber risks and recommends mitigation measures to improve resilience, survivability, and operational readiness. The analyst must also have a basic understanding/competency of writing correspondence, to include reports and analyzing data. SM is expected to maintain in good standing with their M-Day unit and stay in standard at ALL times. (ex: HT/WT, ACFT, Medical)

ROLES AND RESPONSIBILITIES

- Evaluate cyber risks to mission-essential functions and critical assets.
- Analyze the likelihood and consequences of cyber incidents.

- Determine risk levels and prioritize mitigation efforts.
- Support risk management decision-making processes.

DESIRED SKILLS

- Cybersecurity assessment techniques
- Technical writing and briefing skills
- Data analysis and risk evaluation
- Network and system security analysis
- Critical thinking and problem-solving
- Report development and presentation
- Associated certificates
- Associated civilian and/or military education

ADDITIONAL POSITION INFORMATION:

Duties may require additional nights and weekends (for travel) aside from unit training assemblies. An Army Mission Assurance Cyber Analyst plays a key role in protecting critical capabilities, identifying vulnerabilities, and ensuring mission continuity across installations and operations. The AMAAT blends operational analysis, risk management, security operations, emergency management, cyber capabilities, infrastructure, and coordination across multiple warfighting functions. Prospective candidates must possess excellent communication skills, a strong sense of initiative, an ability to analyze vast amounts of information, work independently, and brief clearly and concisely.
