- Dual-Status National Guard Federal Technicians are not eligible
- Permission from Federal Unit Commander to serve on State Active Duty
- Passing and current PFT test
- No visible tattoos while wearing duty uniform
- Applicants must have a valid driver's license

- Applicants must have valid Common Access Card
- Ability to access DOD Systems (Microsoft Teams, SharePoint, OneDrive)
- Ability to obtain a DOD Enterprise Email
- Signed Lautenberg Agreement
