Position Title: MEBS Mechanic

*This position is a New York Military Law Section 6 State Active-Duty position

Closing Date: Open until filled.

Minimum Grade: E1

Maximum Expected Grade: E6.

MOS/NEC/Rating: All considered.

Salary: Daily military pay equivalent to active duty utilizing corresponding grade, length of service, and dependency status.

Unit and Location: MEBS Maintenance Facility, Leeds Armory. 2345 State Route 23, Leeds, N.Y. 12451

Selecting Official: Panel interview.

Eligible Candidates: Applicant must be a member in good standing with the New York Naval Militia, or eligible to become a member of the New York Naval Militia.

Position Description: MEBS is seeking a motivated, self-starting mechanic to maintain and repair our fleet of outboard and diesel patrol boats, trailers, and trucks. Additional duties as directed. This military position is full-time state active duty with an expectation of a long-term commitment. Regular travel throughout the State of New York is expected.

Qualifications:

- Ability to travel with flexible hours
- Valid driver license
- Excellent communication and writing skills
- Has separate health insurance or coverage

Preferred Skills and Experience:

- Experience maintaining boat diesel and outboard motors.
- Commercial Driver License (CDL).
- Experience with a wide variety of hand and power tools.

Additional Notes:

-The location of this position is the Leeds Armory, located in Greene County, five miles west of the Village of Catskill. This site is a relatively quiet location in the scenic northern Catskill Mountains. Candidates are expected to live within a reasonable (less than one hour) commuting time of this facility.

-Candidates with backgrounds in boat engine maintenance are particularly desired. The intent for MEBS mechanics is that we will provide training opportunities in order that they become qualified as Mercury Marine outboard technicians.

-Part of the duties include towing trailers on public roadways.

-Candidates may be either drilling Reservists of the U.S. Coast Guard, Marine Corps or Navy; or be veterans of those services. Service members cannot be paid both State Active Duty and Federal Duty on the same day.

-New York State funding for re-location is not available.
