#### 3) OPERATIONS:



a. We have received an initial request from the **City of Rochester Police Department** to participate in a one-day, multi-agency law enforcement exercise on Lake Ontario/Genesee River on either 12 or 13 September. CAPT McKnight is slated to participate in an initial planning conference call on 7AUG at 1200.

b. **Operation Lake Thunder** AAR summary: Operation Lake Thunder wrapped up this past Monday, 31JUL in Youngstown and Buffalo. By all measures, this event was a great success. The processes that initiated the event, the orders and the execution were all in order, and should be used for future, similar operations.

#### As a recap:

MEBS boats (2), the CP trailer, and personnel were requested through NYS DHSES to support the fourday/three-night operation (28-31JUL23). The multi-agency event was mainly focused on cross-border incursions by water, especially smuggling and illegal migration. The area of operations included the Upper Niagara River/Lake Erie IVO Buffalo, and Lower Niagara River/Lake Ontario IVO Youngstown. MEBS provided PB 281 (Buffalo), PB 280 and CP trailer (Youngstown) as platforms. We embarked US Coast Guard and Homeland Security personnel during the assigned patrol periods.

The operation included boat/crews from US Coast Guard, US Border Patrol, NYS DEC Police, NY State Police; in addition to several Canadian agencies on their side of the water.

Based on the assigned patrol periods, the MEBS crews ended up covering nearly half of the tasking. This was due not only to the scheduling but also that the other agencies ended up having to re-direct to other missions that would interrupt their patrol period.

We were able to flex to cover gaps in the schedule to ensure that the mission was completed.

#### Accomplishments include:

-Operating on both the Upper and Lower Niagara River, MEBS (with embarked USCG) made multiple patrols north and south with the closest approaches to Niagara Falls of any agency.

-PB 281 responded to a "Person in Water" call and assisted other agencies in locating the civilian who was found in good condition.

-During a squall on Lake Ontario, a disabled boat was escorted to safe haven by PB 280. The disabled boat was being towed by a fisherman/good Samaritan.

-PB 280 hailed and eventually caused to stop a recreational boater that was being unresponsive to USCG interdiction efforts. The attached photo is of PB 280 crew using spotlight to get the boater's awareness. -USCG intended to use encrypted, hand-held radios for the operation. They were not entirely effective, especially due to line-of-sight limitations. Our MEBS CP and the boats are equipped with tactical communications VHF and satellite phones. We encouraged the use of these assets but were still limited by line-of-sight issues between upper and lower Niagara River sections. The CP was able to maintain tactical awareness of both of our boats using the tracking devices displayed within the trailer. The trailer is equipped with mi-fi, so the iffy internet in that part of Niagara County was not as big of a problem.



While the law enforcement agencies utilized personnel in an overtime status, we were not encumbered by hours spent working and patrolling on our assigned days. The Naval Militia really put on a good face during this operation.</mark>

a. Maintenance issues:

i. PB 400 shaft repair work. The new propeller shafts and couplers have been obtained by FPS Propeller, in Ravena. We will deliver the shafts to Stormy Bay Marine Services next week so they can make the installation in the boat. ETR is 10AUG23.





ii. PB 300 remains NMC due to port power head oil seal failure, and now replacement of lower end. ETR is 10CT23.

iii. Upon return of PB 400 to DET 1, we expect to relocate PB 301 to Tottenville as a training asset for DET 11.
