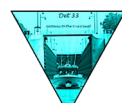

4) LOGISTICS:

a. N4 NOTES: On Monday 8/12/2024 - Wide Load from LEEDS to ATHENS needed for PB301 & LC351 both will be transited to Coxsackie and moored. Note: Radar Arch installed on LC351, PB140 lashed down to deck with motor and gas tank onboard.

Permission to dock both boats at Coxsackie has been obtained. PB301 will depart on Friday 8/16/2024 for Viking Boat Yard (Being Placed on mission with DET 1 8/19/2024 to cover for maintenance period of PB400). LC351 will remain at CYC until departure on 9/4/2024 for canal transit Empire Challenge Note: Anchoring and Swing Circle/ Drag Circle Training to occur onboard





LC351 on Wednesday 8/14/2024 at CYC "MMCM and MMC" in preparation for Empire Challenge Anchorage operations.

On Tuesday 8/13/2024 N4 will depart LEEDS using #19 and towing empty 300 series trailer to John J Burns Park. There we will meet JTFES Engineers and DET3 to conduct loading, launching, trailering training and perform 100 hour service maintenance on both PB300 Verado motors, and LC350 Seapro motors. (DET 3 will transit PB300 from Tappen to John Burns Park to meet us there) JTFES personnel will return LC350 to Jones Beach.

On Wednesday-Thursday 8/14 & 8/15 N4 will support N6 comms team training. Specifically generator operations, trailer grounding, power-up/power down procedures and command trailer equipment and operations.

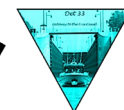
On Friday 8/16 N4 will transit PB301 from CYC to Viking Boat Yard and moor at pier with PB400. On Monday 8/19 PB400 is scheduled to enter a maintenance period at Atlantic Services and PB301 will go on Mission with DET 1 to cover.
