## The following is the status of the New York State Military Emergency Boat Service

#### 1) ADMINISTRATION:

- 2) INFORMATION: (*TSA*) The FBI and DHS are issuing a notification to advise of an ongoing issue of potential public safety concern consequent to the HAMAS attacks in Israel. While FBI and DHS continue to collect and analyze intelligence from a variety of sources, the FBI and DHS do not currently have specific intelligence reflecting additional attack planning against the United States stemming from the HAMAS attacks in Israel which began on 7 October 2023. However, foreign terrorist organizations and their supporters remain committed to attacking the United States within and beyond our borders. In recent years, there have been several events and incidents in the United States that were purportedly motivated, at least in part, by the conflict between Israel and HAMAS. These have included the targeting of individuals, houses of worship, and institutions associated with the Jewish and Muslim faiths with acts of physical assault, vandalism, or harassment. The FBI and DHS encourage the public to promptly report information concerning suspicious activity to tips.fbi.gov or contact their local FBI field office.

# 4) LOGISTICS:

### a. Maintenance issues:

i. PB 440 is FMC after its fall maintenance period last. Fuel lines were updated and routine fall maintenance was completed. The generator set is not installed. It has failed and Atlantic Service is troubleshooting to see if it has any continued life.

- ii. LC 351 is NMC due to high temps on the starboard engine and low engine oil on both engines. We believe we sucked sand into the cooling system on the starboard engine during a beaching demo on Great South Bay on 3OCT. We are also investigating the loss of engine oil. ETR TBD. PB 301 has been moved from Tottenville to Jones Beach as a fill in.
  - iii. PB 300 remains NMC at Leeds. We are awaiting parts from Mercury Marine.
- b. We are planning to keep PB 301 at Viking Boat Yard after the contract with Atlantic Marina in Tottenville expires at the end of October. This means we will have two boats at Viking Boat Yard for the foreseeable future.

# 5) PLANNING AND EXERCISES.

Exercise Empire Challenge After Action:

Fm CAPT Pedersen (NYNM N6) Three Accomplishments:

Successfully tested the new Chameleon™ NVIS antenna. NVIS stands for near vertical incident skywave. This is an easily set up antenna, requiring only a 15' pole in the center. With it, we successfully communicated by voice and digital from Fort Hamilton in Brooklyn to Camp Smith (42 miles), Garden City (18 miles), and Syracuse (200 miles).

Successfully communicated with the Military Emergency Boat Service boats in Long Island Sound, at Jones Beach, and north on the Hudson River using very high frequency (VHF) radio through the Civil Air Patrol (CAP) repeater provided by the Department of Homeland Security Emergency Services (DHSES). VHF is normally limited to line of sight, but the repeater allows long-distance.

Successfully received video (both visible light and infrared spectrum) from a unmanned aerial vehicle (UAV) deployed from the boat on Long Island Sound. The reception in the command post (CP) trailer at Fort Hamilton was crystal clear on the video screen.

LC351 and DHSES successfully tested drone and transmitted video. Video received by CP and observed by ADM Weill in the CP.
