2) INFORMATION: Rates for shipping containers from east Asia and China to both US coasts fell further this week. Rates to the West Coast are about 93% lower than a year ago, and 30% lower than they were at any point in 2019. Rates to the East Coast are 87% below year-ago levels. It remains unclear if volumes that shifted to the East Coast because of backed-up ports and potential labor disruptions will be returning to the West Coast. Shipping analysts said that ports are now "wide open" after working through backlogs created from surging demand during COVID-19 lockdowns. (13MAR23)

5) PLANNING AND EXERCISES.

a. Western Horizon '23 Planning. This event is in early planning, and is to take place in August 2023 on Lake Ontario. Initial concept was to hold this event at USCG Station Sodus Point (a part-time station between Rochester and Oswego), with USCG Reserve boat operators and Wayne County Sheriff marine patrol.



Based on conversation with the Operations Petty Officers from USCG Station Rochester (BM1 Vick) and Station Oswego (BM1 Yeckley), the possibility exists that Station Sodus Point will not open this year. In addition, there is a shortage of boat-qualified USCG Reservists between Rochester and Oswego stations. According to the senior Reserve Coordinator for USCG Sector Buffalo, Reserve (and active-duty) personnel from Sector and Station Buffalo may be available also. The proposed dates of 4-6 AUG 23 may also change. The bottom line is that this event is in a state of flux.

b. Empire Challenge '23 Planning. The Initial Planning Conference for ECX 23 was held on 17MAR. The biggest obstacles that we see right now are:

- i. Access/availability of primary event locations at Floyd Bennett Field, in Brooklyn and Riis Landing in Rockaway. Both locations are managed by the National Park Service. A secondary location to investigate is Kingsborough Community College in Manhattan Beach (Brooklyn).
- ii. Finding a suitable prime mover for the MERC trailer. The prime mover must meet the dimension and weight restrictions of the landing craft, as well as being powerful enough to tow the MERC trailer.
- c. 2023 Events Summary:

19APR23: USCG Sector New York oil pollution exercise at Ft Wadsworth. Sector NY has specifically asked for one of our landing craft to serve as the vessel of interest. We have four NYNM members prepared for this exercise. We anticipate USCG personnel to embark LC-351 for exercise demonstration purposes.

28-30 APR23: MEBS Kick-off Weekend, at the Hudson Power Boat Assn marina in Hudson. Max 30 persons/all boats for the traditional seasonal kick-off training and boat deployment. We intend to capture some imagery of all boats on the river at once from the Hudson-Athens Lighthouse, located in the middle of the river. We intend to transport the keeper(s) by one of our boats to the lighthouse on 29APR.

8-12 MAY 23: NYS PARKS Marine Patrol Vessel Operator Course. We have asked for two seats in this week-long training event on Lake George. NYS Parks pays for lodging and meals. No NYNM boats required. Proposed candidates: BU1 Steve Putney and MA1 Gary Walsh.

Week of 19 JUN 23: Operation AEGIS in Buffalo. A NYS DHSES-sponsored exercise with numerous local, state, federal agencies. We anticipate 3-4 NYNM participants on one NYNM boat. Still very early planning stage. Likely to embark outside agency LE personnel.

20-21 JUL23: Operation Commanding Force. A US Navy Reserve-sponsored exercise at Alexandria Bay, along with US Coast Guard Station A-Bay in response mode. With two NYNM boats and approximately eight NYNM members providing platforms for USNR Sailors to jump in the river and be "rescued" by USCG. USNR medical unit has specifically requested our help with this event. Similar to the event held in 2022.

Week of 24 JUL23: Operation AEGIS on Lake Champlain. A NYS DHSES-sponsored exercise with numerous local, state, federal agencies. We anticipate 3-4 NYNM participants on one NYNM boat. Still very early planning stage. Likely to embark outside agency LE personnel.

4-6 AUG23: Exercise Western Horizon. Lake Ontario with two NYNM boats and about ten personnel. Potentially, working with USCG Sector Buffalo boats and reserve personnel, as well as possibly local sheriff marine patrols. This event is in flux due to uncertainty about USCG availability.

6-8 SEP 23: Operation AEGIS on Hudson River. A NYS DHSES-sponsored exercise with numerous local, state, federal agencies. We anticipate 3-4 NYNM participants on one NYNM boat. Still very early planning stage. Likely to embark outside agency LE personnel.

25-29 SEP 23: NYS PARKS Marine Patrol Vessel Operator Course. We will ask for two seats for this week-long training event on Lake George. NYS Parks pays for lodging and meals.



3-5OCT23: Exercise Empire Challenge. We anticipate four NYNM boats and an estimated 25 NYNM members for this annual communications exercise, slated for Brooklyn in conjunction with JTFES CPX.

27-29 OCT 23: Fall Round-up. Leeds area. All training boats and vehicles returned to Leeds Armory for training season wrap-up. Anticipate up to 30 participants from NYNM.

7) TRAINING. We are investigating adding ASE training and certification to the N4 shop. It appears to be within our reach.
