1) ADMINISTRATION:

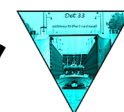
- a. We are aware that personnel have not received travel reimbursement for events going back to September 2023. We are trying to be the squeaky wheel to get the claims processed.

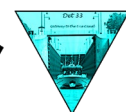
4) LOGISTICS:

 - i. PB 440 is awaiting some fender repair parts from Atlantic Service. We estimate the charges about \$5600.00
 - ii. PB 300 has hydraulic steering leak on port side. Remaining parts on order
 - iii. PB 220 and 221, replacing battery compartment cover latches. Parts delivery was messed up. New ETA is 26JAN24.
