# The following is the status of the New York State Military Emergency Boat Service

## 1) ADMINISTRATION:

- a. The B-1184 request to purchase new Mercury SeaPro 300HP motors for LC-350 has been approved. The requisition has been submitted in SFS to buy the engines through Coeymans Landing Marine Services.
- b. We are instituting a formalized standard for MEBS applicants. We are finding that too many applicants do not have the background or skills needed. Although we are below end-strength, it does not help to have applicants who are not committed to improving the program and are just a drain against our readiness. We want our members to find and refer quality candidates for membership in MEBS, not just anyone who thinks it would be cool to go for a boat ride. Our MEBS personnel history has far too many who do not meet the minimum standard of two proficiency training events per year.
- c. TAG has approved our proposal for FY24 Port Security Grant Program request for PB440 maintenance reimbursement. When the announcement is made in the Spring 2024, we will be ready with our proposal.
