

SUBJECT: New York National Guard Implementation of Sexual Assault Incident Response Oversight (SAIRO) Report

1. References:

- a. Directive-Type Memorandum (DTM) 14007, 30 September 2014, SAIRO Report.
- b. Chief National Guard Bureau Notice (CNGBN) 1303, 11 March 2015, SAIRO Report.

2. The Sexual Assault Incident Response Oversight (SAIRO) Report is a one-time requirement for Unrestricted Reports of Sexual Assault. The report must be completed within 8 calendar days of the signing of the Victim Reporting Preference Statement form, DD Form 2910. The purpose is to provide the General Officer-level Commander with visibility and oversight of the local response to a sexual assault.

3. The victim's assigned Wing Commander or GOCOM Chief of Staff will prepare the SAIRO report in coordination with the JFHQ Sexual Assault Response Coordinator (SARC), Staff Judge Advocate (SJA), and Civilian Law Enforcement (CLE). Templates for the SAIRO report are located on the DMNA SAPR website at <http://dmna.ny.gov/sapr/?nav=resources>.

4. The completed report will be routed by the Wing Commander or GOCOM Chief of Staff through the first General Officer in their chain of command to The Adjutant General. The JFHQ-SARC will receive a copy of the report and maintain in the victim's file until the case is closed.
